A RESOLUTION ACCEPTING BIDS IN CONNECTION WITH THE BRADLEY FIRE DEPARTMENT ADDITION AND REMODELING PROJECT

WHEREAS, the Corporate Authorities of the Village of Bradley, Kankakee County, Illinois, have the authority to adopt resolutions and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens; and

WHEREAS, on or around September 11, 2021, the Village published an advertisement for bids for the pending Fire Department Addition and Remodeling Project (the "Project"); and

WHEREAS, the Village opened and reviewed all bids received in relation to the Project on September 28, 2021; and

WHEREAS, the Corporate Authorities of the Village have determined that Hamann Wagner Excavating, Inc. and Kevin Nugent Construction, Inc. (herein after referred to as the "Vendors") were the lowest responsible bidders for each respective contract included in the Project; and

WHEREAS, the Corporate Authorities of the Village have determined that it is necessary, expedient, and in the best interests of the Village and its citizens to accept the bid from Hamann Wagner Excavating, Inc. ("Wagner"), in the total amount of one hundred ninety-five thousand six hundred fifty-one and 00/100 dollars (\$195,651.00) for the sitework in connection with the Project (a copy of the Wagner bid is attached hereto as Exhibit A and fully incorporated herein); and

WHEREAS, the Corporate Authorities of the Village have determined that it is necessary, expedient, and in the best interests of the Village and its citizens to accept the bid from Kevin Nugent Construction, Inc. ("Nugent"), in the total amount of fifty-two thousand two hundred fourteen and 00/100 dollars (\$52,214.00) for the concrete foundation contract for the Project (a copy of the Nugent bid is attached hereto as Exhibit B and fully incorporated herein).

NOW THEREFORE, BE IT RESOLVED BY THE CORPORATE AUTHORITIES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:

SECTION 1. The Corporate Authorities hereby find that all of the recitals contained in the preamble to this Resolution are true, correct, and complete and are hereby incorporated by reference hereto and made a part hereof.

SECTION 2. The Corporate Authorities of the Village hereby find and declare that the bid received by Hamann Wagner Excavating, Inc. for the sitework contract in connection with the Project, a copy which is attached hereto as Exhibit A and fully incorporated herein, is fair, reasonable, and acceptable to the Village and hereby awards said contract to Wagner for the total amount of one hundred ninety-five thousand six hundred fifty-one and 00/100 dollars (\$195,651.00).

SECTION 3. The Corporate Authorities of the Village hereby find and declare that the bid received by Kevin Nugent Construction, Inc. for the concrete foundation contract in connection with the Project, a copy which is attached hereto as Exhibit B and fully incorporated herein, is fair, reasonable, and acceptable to the Village and hereby awards said contract to Nugent for the total amount of fifty-two thousand two hundred fourteen and 00/100 dollars (\$52,214.00).

SECTION 4. The Corporate Authorities of the Village hereby authorize and direct the Chief of the Bradley Fire Department to take any actions necessary to effectuate the intent of this Resolution, which is to accept the bids from each of the vendors for the Project and to award each such vendor the respective contract bid for.

SECTION 5. In the event that any provision or provisions, portion or portions, or clause or clauses of this Resolution shall be declared to be invalid or unenforceable by a Court of competent jurisdiction, such adjudication shall in no way affect or impair the validity or enforceability of any of the remaining provisions, portions, or clauses of this Resolution that may be given effect without such invalid or unenforceable provision or provisions, portion or portions, or clause or clauses.

SECTION 6. All ordinances, resolutions, motions, or parts thereof, conflicting with any of the provisions of this Resolution, are hereby repealed to the extent of the conflict.

SECTION 7. The Village Clerk is hereby directed to publish this Resolution in pamphlet form.

SECTION 8. This Resolution shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.

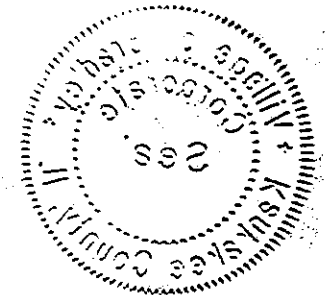
