

RESOLUTION NO. R-11-15-2

**A RESOLUTION ADOPTING AN ESTIMATED 2015
PROPERTY TAX LEVY**

WHEREAS, the *Truth in Taxation Law*, 35 ILCS 200/18-55 *et seq.* (“Truth in Taxation Law”), requires that all taxing districts in the State of Illinois determine the estimated amounts of taxes necessary to be levied for the year not less than 20 days prior to the official adoption of the aggregate tax levy of the Village of Bradley (“Village”); and

WHEREAS, if the estimated aggregate amount necessary to be levied, exclusive of election costs and bond and interest costs, exceeds 105% of the aggregate amount of property taxes extended or estimated to be extended, including any amount abated by the taxing district prior to such extension, upon the levy of the preceding year, public notice shall be given and a public hearing shall be held on the Village's intent to adopt a tax levy in an amount which is more than 105% of such extension or estimated extension for the preceding year; and

WHEREAS, the amount of property taxes extended or estimated to be extended on the Village's aggregate levy for 2014 was \$2,074,593.38; and

WHEREAS, it is hereby determined that the estimated aggregate levy necessary for the year 2015 upon the taxable property of the Village is \$2,086,338.

NOW THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of Bradley, as follows:

Section 1. Recitals Incorporated. The above recitals are incorporated into this Resolution and shall have the same force and effect as though fully set forth herein.

Section 2. Estimated 2015 Tax Levy. The estimated aggregate levy for the year 2015 is \$2,086,338.

Section 3. Tax Levy for 2014. The estimated aggregate levy for the year 2015 does not exceed 105% of the taxes extended, including any amount abated prior to such extension, on the aggregate levy of the Village for the year 2014.

Section 4. Truth in Taxation Law. In light of Sections 2 and 3 above, the provisions of sections 18-65 through 18-85 of the Truth in Taxation Law do not apply to the adoption of the 2015 aggregate levy and the Village is not required to publish notice of or conduct a hearing thereon.

Section 5. Severability and Repeal of Inconsistent Resolutions and Ordinances. If any section, paragraph, clause or provision of this Resolution shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Resolution. All existing resolutions and ordinances of the Village of Bradley are hereby repealed insofar as they may be inconsistent with the provisions of this Resolution.

Section 6. Effective Date. This Resolution shall be in full force and effect upon its passage and approval.

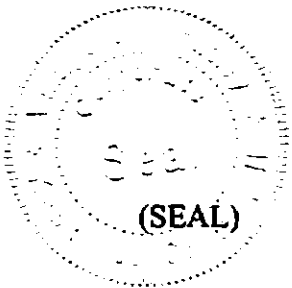

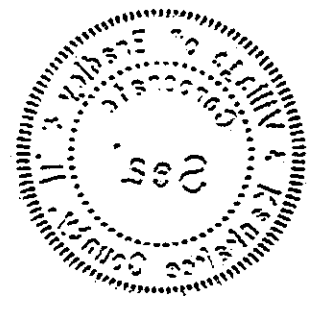
