**A RESOLUTION APPROVING A SUBORDINATION OF
SURFACE RIGHTS FOR PUBLIC ROAD PURPOSES TO THE
ILLINOIS DEPARTMENT OF TRANSPORTATION**

WHEREAS, the Village of Bradley (“Village”) is an Illinois municipal corporation, organized and existing pursuant to the Illinois Municipal Code, 65 ILCS 5/1-1-1 et seq.; and

WHEREAS, the Illinois Department of Transportation has improved a portion of I-57, but is unable to complete its right of way acquisition process until such time as the Village of Bradley subordinates its surface rights;

NOW THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of Bradley, as follows:

Section 1. Recitals Incorporated. The above recitals are incorporated herein by reference as though fully set forth.

Section 2. Subordination of Surface Rights for Public Road Purposes Approved. The Subordination of Surface Rights for Public Road Purposes, as attached hereto as Group Exh. A, between the Village and the State of Illinois Department of Transportation is approved, subject to the review and approval of the Village Attorney and Village Engineer.

Section 3. Execution of Agreement. The Village President is directed to execute the Subordination of Surface Rights for Public Road Purposes in substantially the form attached as Exhibit A, subject to the review and approval of the Village Attorney and Village Engineer.

Section 4. Severability and Repeal of Inconsistent Ordinances and Resolutions. If any section, paragraph, clause or provision of this Resolution shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Resolution. All existing resolutions of the Village of Bradley are hereby repealed insofar as they may be inconsistent with the provisions of this Resolution.

Section 5. Effective Date. This Resolution shall be in full force and effect from and after its passage and approval as provided by law.


