RESOLUTION NO. R-12-15-4

A RESOLUTION AUTHORIZING A MORTGAGE SUBORDINATION AGREEMENT BETWEEN THE VILLAGE OF BRADLEY, COMMERCE STATE BANK, AND BRADLEY HOTEL CORPORATION

WHEREAS, the Village of Bradley ("Village") previously extended a note ("Note") to Bradley Hotel Corporation ("Hotel") in the amount of \$431,978.11 as part of the Village's revolving loan fund. Said note was recorded with the Kankakee County Recorder of Deeds as document no. 200509523; and

WHEREAS, the Hotel wishes to secure financing in the amount of \$150,000.00 from Commerce State Bank ("Bank") for business purposes at the premises against which the Note is recorded, to wit the Quality Inn on IL State Route 50 in Bradley, Illinois. However, the subordination agreement *does* contain a provision that allows the Hotel to potentially expend loan funds "for purposes other than improvement of the land"; and

WHEREAS, the Bank and Hotel are requesting that, as a condition of the Hotel securing the aforesaid financing, the Village agree to subordinate its Note, thus making Commerce State Bank's loan superior to the Village's Note. A copy of the Hotel's proposed Subordination Agreement is attached hereto as *Exh. A*.

NOW THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of Bradley, as follows:

Section 1. **Approval of Authority to Execute the Subordination Agreement.** The President and Board of Trustees of the Village of Bradley approve the subordination agreement and agree to subordinate the Village's Note to Commerce State Bank's loan. The Village President and Village Clerk are hereby authorized to execute any and all documents as may be necessary to effect said Agreement.

Section 2. **Effective Date.** This Resolution shall be in full force and effect upon its passage and approval.

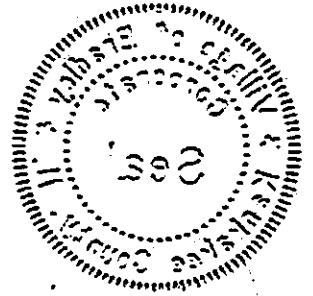
