**RESOLUTION NO. R-12-18-3**

**A RESOLUTION AUTHORIZING THE EXTENSION OF THE VILLAGE'S  
ENGAGEMENT WITH LAUTERBACH & AMEN, LLP, TO PROVIDE FINANCIAL  
AUDITING SERVICES**

**WHEREAS**, the President and Board of Trustees of the Village of Bradley, Kankakee County, Illinois, have the authority to adopt resolutions and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens; and

**WHEREAS**, the Section 8-8-3 of the Illinois Municipal Code (65 ILCS 5/8-8-3) and Section 2-465 of the Bradley Village Code require that the Village's finances be audited annually; and

**WHEREAS**, the Village presently employs the firm of Lauterbach & Amen, LLP (the "Company"), to perform its audits; and

**WHEREAS**, the Corporate Authorities of the Village are satisfied with the quality of work provided by the Company; and

**WHEREAS**, the Corporate Authorities of the Village wish to continue employing the Company to provide audits for the financial years ending on April 30, 2019, April 30, 2020, and April 30, 2021; and

**WHEREAS**, the Company has provided the Village with a written proposal outlining the terms of the Company's continued engagement with the Village (the "Agreement")—a copy of the Agreement is attached hereto as Exhibit A and fully incorporated herein; and

**WHEREAS**, the Corporate Authorities of the Village have determined that the terms of the Agreement are reasonable and acceptable to the Village and that executing said agreement is in the best interests of the Village and its citizens; and

**WHEREAS**, the Corporate Authorities of the Village desire to enter into the Agreement with the Company and thereby secure continued auditing services from the Company for the financial years ending on April 30, 2019, April 30, 2020, and April 30, 2021.

**NOW THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:**

**SECTION 1.** The President and Board of Trustees hereby find that all of the recitals contained in the preamble to this Resolution are true, correct, and complete and are hereby incorporated by reference hereto and made a part hereof.

**SECTION 2.** The Corporate Authorities of the Village hereby find that the terms and provisions of the Agreement, attached hereto as Exhibit A and fully incorporated herein, are reasonable and acceptable to the Village and approve said agreement in form and substance.

**SECTION 3.** The Corporate Authorities of the Village hereby authorize and direct the Village President to execute the Agreement, and further to take any action and sign any document that is necessary, in his sole discretion, to fully effectuate the intent of this resolution.

**SECTION 4.** In the event that any provision or provisions, portion or portions, or clause or clauses of this Resolution shall be declared to be invalid or unenforceable by a Court of competent jurisdiction, such adjudication shall in no way affect or impair the validity or enforceability of any of the remaining provisions, portions, or clauses of this Resolution that may be given effect without such invalid or unenforceable provision or provisions, portion or portions, or clause or clauses.

**SECTION 5.** All ordinances, resolutions, motions, or parts thereof, conflicting with any of the provisions of this Resolution, are hereby repealed to the extent of the conflict.

**SECTION 6.** The Village Clerk is hereby directed to publish this Resolution in pamphlet form.

**SECTION 7.** This Resolution shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.

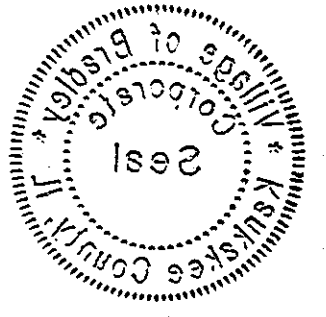



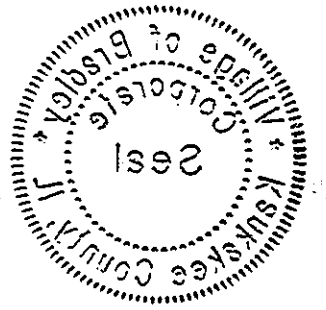
