A RESOLUTION OF SUPPORT AND COMMITMENT OF LOCAL FUNDS

WHEREAS, the Village of Bradley, is applying to the State of Illinois for a Community Development Block Grant (CDBG) RLF Close-out grant,

WHEREAS, it is necessary that an application be made and agreements be entered into with the State of Illinois, and

WHEREAS, receipt of CDBG grant assistance is necessary to allow the Village of Bradley to undertake the project to repair and re-pave public streets and repair, replace, and fill in existing sidewalks to make them ADA compliant in predominantly low-to-moderate income target areas as identified in its application, and

WHEREAS, financial participation by the grantee, in conjunction with CDBG funds, is required to complete the project, and

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY AS FOLLOWS:

- 1) that the Village of Bradley apply for a grant under the terms and conditions of the State of Illinois and shall enter into and agree to the understandings and assurances contained in said application.
- 2) that the Mayor Pro Tem and Village Clerk on behalf of the Village of Bradley execute such documents and all other documents necessary for the carrying out of said application.
- 3) that the Mayor and Village Clerk are authorized to provide such additional information as may be required to accomplish the obtaining of such grant.
- 4) that the Village of Bradley does hereby commit funds from its Capital Fund for use in conjunction with the Illinois Community Development Block Grant RLF Close-out grant, such funds to equal approximately 11.9% of the estimated total project cost of \$2,282,573, or \$272,623.32.

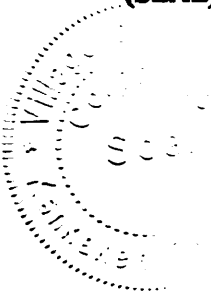
