**A RESOLUTION AUTHORIZING A TWO MONTH EXTENSION OF THE MUNICIPAL
WASTE HAULING CONTRACT**

WHEREAS, the Corporate Authorities of the Village of Bradley, Kankakee County, Illinois, have the authority to adopt resolutions and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens; and

WHEREAS, pursuant to Section 2-3-8 of the Illinois Municipal Code (65 ILCS 5/2-3-8) the Corporate Authorities of the Village are authorized to enter into contracts on behalf of the Village that serve the Village's legitimate corporate purposes; and

WHEREAS, the Village previously entered into a Waste Hauling Contract with Allied of Mومence a Division of Republic Services Company; and

WHEREAS, the Waste Hauling Contract entered into between the Village and Allied of Mومence a Division of Republic Services Company expires on April 30, 2021; and

WHEREAS, a two (2) month extension (until June 30, 2021) of the contract is being sought to allow Village staff to address the Village's waste hauling contract and will help avoid any service interruption. A copy of the proposed extension (the "Agreement"), is attached hereto as Exhibit A and fully incorporated herein; and

WHEREAS, the Corporate Authorities of the Village have determined that entering into the Agreement with Allied is in the best interests of the Village and its citizens.

NOW THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:

SECTION 1. The Corporate Authorities hereby find that all of the recitals contained in the preamble to this Resolution are true, correct, and complete and are hereby incorporated by reference hereto and made a part hereof.

SECTION 2. The Corporate Authorities of the Village hereby determine and declare that the proposed Agreement to extend the Waste Hauling Contract entered into between the Village and Allied of Mومence a Division of Republic Services Company by two Months, until June 30, 2021, a copy of which is attached hereto as Exhibit A and fully incorporated herein, to be in the best interest of the Village. To the extent necessary, the Corporate Authorities of the Village hereby authorize and direct the Mayor to execute any documents necessary to allow for said extension.

SECTION 3. In the event that any provision or provisions, portion or portions, or clause or clauses of this Resolution shall be declared to be invalid or unenforceable by a Court of competent jurisdiction, such adjudication shall in no way affect or impair the validity or enforceability of any of

the remaining provisions, portions, or clauses of this Resolution that may be given effect without such invalid or unenforceable provision or provisions, portion or portions, or clause or clauses.

SECTION 4. That all ordinances, resolutions, motions, or parts thereof, conflicting with any of the provisions of this Resolution, are hereby repealed to the extent of the conflict.

SECTION 5. That the Village Clerk is hereby directed to publish this Resolution in pamphlet form.

SECTION 6. That this Resolution shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.

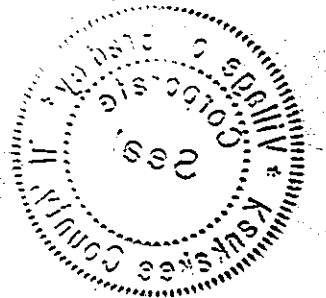

Dear Mayor Watson and Finance Director Rob Romo,

This is a follow up regarding the proposal that was forwarded to the both of you on February 26, 2021 and April 16th, 2021. The previous proposals being offer were for a three-year extension and an Eight (8) month & Two (2) month proposal with the current contract set to expire on April 30, 2021. Republic Services believes that being a great partner includes the residents that they service. Republic Services is happy to propose a two (2) -month extension to avoid any the service interruption to the fine citizens of Bradley. The propose extension on the current contract would now extend to June 30, 2021.

- Republic Services will continue to operate with the same safe and efficient routes that are currently in place.
- Republic Services will continue to purchase and maintain the necessary in Insurance and Bonds set forth in the current contract.

- Republic Services will always continue to have back up trucks available for pick up to the Village neither before 6:00 AM nor after 7:00 PM.
