

## RESOLUTION R-5-15-1

### **A RESOLUTION PROCLAIMING THE RESULTS OF THE CONSOLIDATED ELECTION HELD WITHIN THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS ON THE 7TH DAY OF APRIL, 2015**

**WHEREAS**, a consolidated election was conducted in the Village of Bradley, Kankakee County, Illinois, on the 7th day of April, 2015, for the purpose of electing three (3) persons to the office of Village Trustee (three four-year terms); and

**WHEREAS**, the election was called in accordance with law, the votes were cast, and the Kankakee County Clerk has canvassed the votes and declared and proclaimed the results of the election; and

**WHEREAS**, the Board of Trustees of the Village of Bradley desire to proclaim and declare the results of the consolidated election so that the results are included in the permanent records of the Village of Bradley.

**NOW THEREFORE, BE IT RESOLVED** by the President and Board of Trustees of the Village of Bradley, as follows:

**Section 1. Recitals Incorporated.** The above recitals are incorporated herein as though fully set forth.

**Section 2. Conduct of Consolidated Election.** A consolidated election was held pursuant to law in the Village of Bradley, Kankakee County, Illinois on April 7, 2015. On April 22, 2015, the Kankakee County Clerk canvassed the votes of the consolidated election and declared and proclaimed that the number of total ballots cast was 1,137.

**Section 3. Proclamation of Election of Village Trustees.** The Kankakee County Clerk canvassed the votes for the election of three (3) persons to the office of Village Trustee, and Laurel Lori Gadbois received 612 votes, Gerald Balthazor received 551 votes, George Golwitzer received 526 votes, Michael Watson received 554 votes, Charles Burke received 434 votes, and Brian Tieri received 458 votes. Laurel Lori Gadbois, Gerald Balthazor and Michael Watson were each declared and proclaimed elected Village Trustees.

**Section 4. Certification by Kankakee County Clerk.** On April 22, 2015, the Kankakee County Clerk certified the above election results and issued an "Abstract of Votes", a copy of which is attached hereto and incorporated herein by reference.

**Section 5. Severability and Repeal of Inconsistent Resolutions.** If any section, paragraph, clause or provision of this Resolution shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Resolution. All existing resolutions of the Village of Bradley are hereby repealed insofar as they may be inconsistent with the provisions of this Resolution.

**Section 6. Effective Date.** This Resolution shall be in full force and effect immediately after its passage as provided by law.

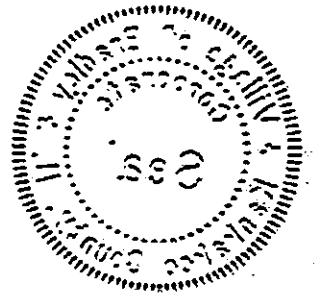
