ORDINANCE NO. R-5-17-3

**A RESOLUTION AUTHORIZING THE VILLAGE OF BRADLEY TO OBTAIN
A PERMIT FROM THE ILLINOIS DEPARTMENT OF TRANSPORTATION FOR A
COMMERCIAL ENTRANCE ALONG ILLINOIS ROUTE 50 AND TO FULFILL OTHER
ILLINOIS DEPARTMENT OF TRANSPORTATION REQUIREMENTS ASSOCIATED
WITH SAID WORK**

WHEREAS, the Village of Bradley located in the county of Kankakee, State of Illinois, wishes to allow Construction of a commercial entrance along IL Rte. 50, which by law comes under the jurisdiction and Control of the Illinois Department of Transportation; and

WHEREAS, a permit from said department is required before said work can be legally undertaken by said Village of Bradley;

NOW, THEREFORE, BE IT RESOLVED by the President and the Board of Trustees of the Village of Bradley, Kankakee County, State of Illinois, as follows:

FIRST: That we (the Village) do hereby request from the Illinois Department of Transportation, a permit authorizing the Village of Bradley to proceed with the work herein described and as shown on enclosed detailed plans.

SECOND: Upon completion of the commercial entrance by the contractor and acceptance by the Village, The Village guarantees that all work has been performed in accordance with the conditions of the permit to be granted by the Illinois Department of Transportation.

Further, the village will hold the State of Illinois harmless for any damages that may occur to persons or property during such work.

The Village will require the contractor to obtain a bond and a comprehensive general liability insurance policy in acceptable amounts and will require the contractor to add the State of Illinois as an additional insured on both policies.

THIRD: That we (the Village) hereby state that the proposed work is not to be performed by the employees of the Village of Bradley.

FOURTH: That the proper officers of the Village of Bradley are hereby instructed and authorized to sign said permit on behalf of the Village of Bradley.

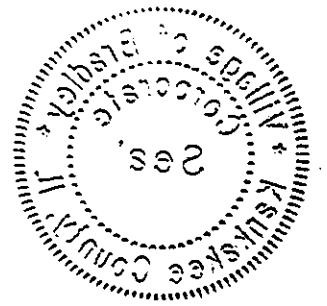
