**A RESOLUTION PROCLAIMING THE RESULTS OF THE CONSOLIDATED
ELECTION HELD WITHIN THE VILLAGE OF BRADLEY, KANKAKEE
COUNTY, ILLINOIS ON THE 4TH DAY OF APRIL 2017**

WHEREAS, a consolidated election was conducted in the Village of Bradley, Kankakee County, Illinois, on the 4th day of April, 2017, for the purpose of electing a person to the office of Village President (one four-year term), a person to the office of Village Clerk (one four-year term), one person to the office of Village Trustee (one four-year term) and one person to the office of Village Trustee (one two-year term); and

WHEREAS, the election was called in accordance with law, the votes were cast, and the Kankakee County Clerk has canvassed the votes and declared and proclaimed the results of the election; and

WHEREAS, the Board of Trustees of the Village of Bradley desire to proclaim and declare the results of the consolidated election so that the results are included in the permanent records of the Village of Bradley.

NOW, THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of Bradley, Kankakee County, Illinois, as follows:

Section 1. Recitals Incorporated. The above recitals are incorporated herein as though fully set forth.

Section 2. Conduct of Consolidated Election. A consolidated election was held pursuant to law in the Village of Bradley, Kankakee County, Illinois on April 4, 2017. On April 18, 2017, the Kankakee County Clerk canvassed the votes of the consolidated election and declared and proclaimed that the total ballots case was 2,185.

Section 3. Proclamation of Election of Village President. The Kankakee County Clerk canvassed the votes for the election to the office of Village President, and Bruce Adams received a total of 1,317 votes and Michael Watson received 842 votes. Bruce Adams was declared and proclaimed elected Village President.

Section 4. Proclamation of Election of Village Clerk. The Kankakee County Clerk canvassed the votes for the election to the office of Village Clerk, and Michael LaGesse received 1,249 votes and Julie Tambling received 860. Michael LaGesse was declared and proclaimed elected Village Clerk.

Section 5. Proclamation of Election of Village Trustees. The Kankakee County Clerk canvassed the votes for the election three (3) persons to the office of Village Trustee, and Robert Redmond received 1,039 votes, Jaclyn Dugan-Roof received 1,114 votes, Curt West received 550 votes, Donald Barber received 956 votes, Brian Tieri received 725 votes, David Schultz received 744 votes and Melissa Carrico received 585 votes. Robert Redmond, Jaclyn Dugan-Roof and Donald Barber were each declared and proclaimed elected Village Trustees.

Section 6. Certification by Kankakee County Clerk. On April 18, 2017, the Kankakee County Clerk certified the above election results and issued an "Abstract of Votes," a copy of which is attached hereto and incorporated herein by reference.

Section 8. Severability and Repeal of Inconsistent Ordinances, Resolutions and Motions. If any section, paragraph, clause or provision of this Resolution shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this resolution. All ordinances, resolutions or adopted motions in conflict herewith are hereby repealed to the extent of such conflict.

Section 9. Effective Date. This Resolution shall be in full force and effect immediately after its passage as provided by law.

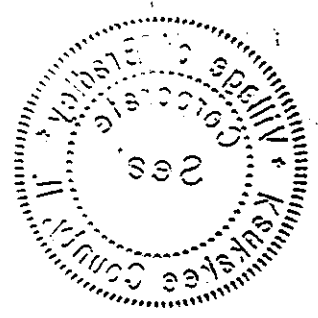
