WHEREAS, the Village of Bradley has determined that it is in its best interests to enter into the attached Intergovernmental Agreement (“Intergovernmental Agreement”) with the County of Kankakee, City of Kankakee, City of Momence, Village of Bourbonnais, and Village of Manteno to promote tourism.

NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, BY AND PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:

SECTION 1. The Village President and Board of Trustees hereby find that all of the recitals contained in the preamble to this Resolution are true, correct and complete and are hereby incorporated by reference thereto and made a part hereof.

SECTION 2. The attached Intergovernmental Agreement between the Village of Bradley, the County of Kankakee, City of Kankakee, City of Momence, Village of Bourbonnais, and Village of Manteno is hereby approved subject to final review and approval of the Village Attorney, and the Village President is authorized to execute said Intergovernmental Agreement on behalf of the Village of Bradley.

SECTION 3. This Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.
