**RESOLUTION NO. R-8-17-2**

**A RESOLUTION RELATING TO PARTICIPATION BY ELECTED OFFICIALS IN THE ILLINOIS MUNICIPAL RETIREMENT FUND**

**WHEREAS**, the President and Board of Trustees of the Village of Bradley, Kankakee County, Illinois, have the authority to adopt resolutions and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens; and

**WHEREAS**, the Village of Bradley, Kankakee County, Illinois, is a participant in the Illinois Municipal Retirement Fund (“IMRF”); and

**WHEREAS**, the Village of Bradley previously and pursuant to Section 7-137 of the Illinois Pension Code (40 ILCS 5/7-137) elected to exclude from participation in and eligibility for the IMRF all persons who are employed by the Village in any position that normally requires the performance of a duty on behalf of the Village for fewer than 1000 hours a year; and

**WHEREAS**, pursuant to Section 7-137 of the Illinois Pension Code (40 ILCS 5/7-137) and relevant portions of the Village code, elected officials of the Village of Bradley may participate in the IMRF, but only if they hold positions that normally require the performance of a duty for not less than 1000 hours a year, unless otherwise permitted by the IMRF; and

**WHEREAS**, the President and Board of Trustees of the Village of Bradley are authorized to determine which of the Village’s elected officials (offices) qualify for participation in the IMRF and to further provide guidance and direction on the question of eligibility to the Board of Trustees of the IMRF (“IMRF Board”); and

**WHEREAS**, the IMRF Board has requested, in its Special Memorandum #337, that the Village of Bradley pass a resolution recertifying which of the Village’s elected officials qualify for participation in the IMRF; and

**WHEREAS**, the President and Board of Trustees of the Village of Bradley have determined that the office of Village President satisfies the annual hourly requirements for participation in the IMRF because the office of Village President is one that normally requires the performance of a duty for not less than 1000 hours a year; and

**WHEREAS**, the President and Board of Trustees of the Village of Bradley have determined that the office of Village Trustee satisfies the annual hourly requirements for participation in the IMRF because the office of Village Trustee is one that normally requires the performance of a duty for not less than 1000 hours a year.

**NOW THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:**

**SECTION 1.** The President and Board of Trustees hereby find that all of the recitals contained in the preamble to this Resolution are true, correct, and complete and are hereby incorporated by reference hereto and made a part hereof.

**SECTION 2.** That the President and Board of Trustees of the Village of Bradley hereby find and determine that the following elected officials (offices) qualify for participation in the IMRF:

<b><u>Title of Elected Position</u></b>	<b><u>Date Position Became Qualified</u></b>
Village President	April 4, 2017
Village Trustee	April 4, 2017

Provided however that, to the extent that the IMRF may require further proof regarding the total number of hours worked by any elected official occupying one of the aforementioned offices, it shall be incumbent upon each such elected official to supply the IMRF with any and all documentation necessary to satisfy the IMRF's inquiry and demonstrate that said elected official is duly qualified for participation in the IMRF. In passing this resolution, the President and Board of Trustees of the Village of Bradley certify only that the elected offices set out above can entail the performance of duties of not less than 1000 hours a year, and not that any individual elected official has or will actually perform any such duty for more than 1000 hours a year.

**SECTION 3.** That the Village Clerk is hereby instructed to serve a copy of this resolution on the IMRF on or before September 1, 2017.

**SECTION 4.** In the event that any provision or provisions, portion or portions, or clause or clauses of this Resolution shall be declared to be invalid or unenforceable by a Court of competent jurisdiction, such adjudication shall in no way affect or impair the validity or enforceability of any of the remaining provisions, portions, or clauses of this Resolution that may be given effect without such invalid or unenforceable provision or provisions, portion or portions, or clause or clauses.

**SECTION 5.** That all ordinances, resolutions, motions, or parts thereof, conflicting with any of the provisions of this Resolution, are hereby repealed to the extent of the conflict.

**SECTION 6.** That the Village Clerk is hereby directed to publish this Resolution in pamphlet form.

**SECTION 7.** That this Resolution shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.

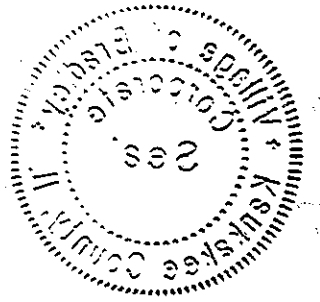
