**A RESOLUTION AUTHORIZING FUNDING AND PARTICIPATION IN
THE COMMUNITY TOURISM ACTION PLAN PROGRAM**

WHEREAS, the Village of Bradley ("Village") is an Illinois municipal corporation, organized and existing pursuant to the Illinois Municipal Code, 65 ILCS 5/1-1-1 et seq., located in the County of Kankakee, State of Illinois; and

WHEREAS, the Village deems its best interests are served by participating in the Community Tourism Action Plan ("CTAP") Program; and

WHEREAS, the CTAP is a community-oriented tourism marketing and development investment program initiated by the Kankakee County Convention & Visitors Bureau; and

WHEREAS, the Village desires to realize its brand vision, meet its community/destination challenges, and deliver on its tourism brand promise; and

WHEREAS, the Village anticipates the initiatives to be sponsored by the Chamber of Commerce, Convention & Visitors Bureau and the Village of Bradley; and

WHEREAS, the Village of Bradley approves two thousand dollars (\$2,000) on a twenty percent (20%) matching basis on a ten thousand dollar (\$10,000) project funding basis, for a total potential project funding of twelve thousand dollars (\$12,000).

NOW THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of Bradley, as follows:

Section 1. Recitals Incorporated. The above recitals are incorporated herein by reference as though fully set forth.

Section 2. Funding Approved. The Village of Bradley approves two thousand dollars (\$2,000) on a twenty percent (20%) matching basis on a ten thousand dollar (\$10,000) project funding basis, for a total potential project funding of twelve thousand dollars (\$12,000).

Section 3. Execution of Agreement. The Village President and Village Clerk are hereby authorized to sign, execute and deliver all documents necessary to become party to the CTAP program for community tourism partnership funding.

Section 4. Severability and Repeal of Inconsistent Ordinances and Resolutions. If any section, paragraph, clause or provision of this Resolution shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Resolution. All existing resolutions of the Village of Bradley are hereby repealed insofar as they may be inconsistent with the provisions of this Resolution.

Section 5. Effective Date. This Resolution shall be in full force and effect from and after its passage and approval as provided by law.
