**RESOLUTION NO. R-8-21-3**

**A RESOLUTION AUTHORIZING AND APPROVING THE PURCHASE OF A 2021 FORD F250 PICKUP TRUCK FOR THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS**

**WHEREAS**, the Corporate Authorities of the Village of Bradley, Kankakee County, Illinois, have the authority to adopt resolutions and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens; and

**WHEREAS**, pursuant to Section 2-3-8 of the Illinois Municipal Code (65 ILCS 5/2-3-8), the Corporate Authorities of the Village have the authority to enter into contracts, to make purchases, and to acquire and hold personal property for all legitimate corporate purposes; and

**WHEREAS**, the Corporate Authorities of the Village have determined that it is necessary, expedient, and in the best interests of the Village and its citizens to purchase a 2021 Ford F250 pickup truck for use by the Bradley Public Works Department (the "Vehicle"); and

**WHEREAS**, Village Staff have identified that Bob Ridings Fleet Sales, 931 Springfield Road, Taylorville, Illinois, 62568 (the "Vendor"), is ready and willing to sell the Vehicle to the Village in a manner and timeframe that fits the Village's present needs; and

**WHEREAS**, Village Staff have determined that the Vehicle is not reasonably available from other sources, in part due to shortages and supply line disruptions on account of the COVID-19 pandemic; and

**WHEREAS**, the Corporate Authorities of the Village have determined, by a two-thirds (2/3) supermajority vote of the trustees presently holding office, that it is necessary and expedient to waive any and all competitive bidding procedures that might otherwise be applicable to the purchase of the Vehicle; and

**WHEREAS**, the total expected cost for the vehicle is thirty-four thousand seven hundred sixty-two and 00/100 dollars (\$34,762.00); and

**WHEREAS**, the Corporate Authorities of the Village have determined that it is in the best interests of the Village and its citizens to authorize and approve the purchase of the Vehicle from the Vendor at the price stated above, and further to waive competitive bidding in relation to said purchase.

**NOW THEREFORE, BE IT RESOLVED BY THE CORPORATE AUTHORITIES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:**

**SECTION 1.** The Corporate Authorities hereby find that all of the recitals contained in the preamble to this Resolution are true, correct, and complete and are hereby incorporated by reference hereto and made a part hereof.

**SECTION 2.** The Corporate Authorities of the Village hereby authorize and direct the Director of Public Works for the Village of Bradley, Terry Memenga, to purchase one (1) 2021 Ford F250 pickup truck (the "Vehicle") from the Vendor, provided that the total price for the Vehicle shall not exceed thirty-four thousand seven hundred sixty-two and 00/100 dollars (\$34,762.00). Director Memenga is further authorized and directed to take any action and sign any document necessary to accomplish the purchase of the Vehicle, as authorized by this Resolution

**SECTION 3.** The Corporate Authorities hereby waive, by an affirmative vote of two-thirds (2/3) of the trustees presently holding office, any and all competitive bidding requirements as might otherwise be applicable to the purchases authorized by this Resolution.

**SECTION 4.** In the event that any provision or provisions, portion or portions, or clause or clauses of this Resolution shall be declared to be invalid or unenforceable by a Court of competent jurisdiction, such adjudication shall in no way affect or impair the validity or enforceability of any of the remaining provisions, portions, or clauses of this Resolution that may be given effect without such invalid or unenforceable provision or provisions, portion or portions, or clause or clauses.

**SECTION 5.** All ordinances, resolutions, motions, or parts thereof, conflicting with any of the provisions of this Resolution, are hereby repealed to the extent of the conflict.

**SECTION 6.** The Village Clerk is hereby directed to publish this Resolution in pamphlet form.

**SECTION 7.** This Resolution shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.
