# BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BRADLEY, Kankakee County, Illinois, as follows:

<u>Section 1</u>. <u>Village Code Amended</u>. Chapter 4 ("Alcoholic Beverages""), Article III ("Licenses"), Section 4-68 ("Classifications and Amounts of Fees") is hereby amended by adding the underlined to read as follows:

#### Sec. 4-68. Classifications and amounts of fees.

Licenses shall be and are hereby divided into classes, with fees for such licenses as follows:

\* \* \* \*

(12) Class L license. A class L license shall authorize the sale of all kinds of liquor by hotels or motels for consumption on the premises only in a hospitality room, banquet room, bar or lounge, and including room service, but specifically excluding a restaurant. The full amount of the fee for such Class L license shall be as provided in the village fee schedule in section 18-1.

<u>Section 2.</u> <u>Village Code Amended</u>. Chapter 4 ("Alcoholic Beverages"), Article III ("Licenses"), Section 4-77 is hereby amended by deleting the overstricken language and adding the underlined to read as follows:
