ORDINANCE NO. 001-22-01

**AN ORDINANCE AMENDING CHAPTER 18 (FEES AND OTHER CHARGES),
SECTION 18-1 (FEES) OF THE BRADLEY VILLAGE CODE**

WHEREAS, the Corporate Authorities of the Village of Bradley, Kankakee County, Illinois, have the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens; and

WHEREAS, pursuant to Section 65 of the Illinois Video Gaming Act (230 ILCS 40/65), the Corporate Authorities of the Village are authorized to impose an annual fee on the right to operate video gaming terminals in the Village; and

WHEREAS, the Corporate Authorities of the Village previously exercised the foregoing authority by enacting, *inter alia*, Chapter 18 (Fees and other Charges), Section 18-1 (Fees) of the Village code; and

WHEREAS, on December 17, 2021, the Illinois General Assembly passed Public Act 689 (2021 ILL. P.A. 689), which amended Section 65 of the Video Gaming Act to increase the maximum annual fee that the Village can impose on the operation of video gaming terminals from twenty-five and 00/100 dollars (\$25.00) to two hundred fifty and 00/100 dollars (\$250.00); and

WHEREAS, in light of the above-referenced amendment, the Corporate Authorities of the Village have determined that it is necessary, expedient, and in the best interests of the Village and its citizens to amend said Section 18-1 to reflect the new maximum fee permitted by law.

NOW THEREFORE, BE IT ORDAINED BY THE CORPORATE AUTHORITIES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:

SECTION 1. The Corporate Authorities hereby find that all of the recitals contained in the preamble to this Ordinance are true, correct, and complete and are hereby incorporated by reference hereto and made a part hereof.

SECTION 2. Chapter 18 (Fees and other Charges), Section 18-1 (Fees) is hereby amended, in relevant part, to read as follows:

SECTION 3. In the event that any provision or provisions, portion or portions, or clause or clauses of this Ordinance shall be declared to be invalid or unenforceable by a Court of competent jurisdiction, such adjudication shall in no way affect or impair the validity or enforceability of any of the remaining provisions, portions, or clauses of this Ordinance that may be given effect without such invalid or unenforceable provision or provisions, portion or portions, or clause or clauses.

SECTION 4. That all ordinances, resolutions, motions, or parts thereof, conflicting with any of the provisions of this Ordinance, are hereby repealed to the extent of the conflict.

SECTION 5. That the Village Clerk is hereby directed to publish this Ordinance in pamphlet form.

SECTION 6. That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
