AN ORDINANCE AMENDING CHAPTER 20 (FIRE PREVENTION AND PROTECTION), ARTICLE II (FIRE DEPARTMENT), SECTION 20-21 (ESTABLISHED; COMPOSITION) OF THE BRADLEY VILLAGE CODE

WHEREAS, the Corporate Authorities of the Village of Bradley, Kankakee County, Illinois, have the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens; and

WHEREAS, pursuant to Section 11-6-1 of the Illinois Municipal Code (65 ILCS 5/11-6-1), the Corporate Authorities of the Village have the authority to establish a fire department and provide for fire protection within the corporate boundaries of the Village; and

WHEREAS, the Corporate Authorities of the Village have previously exercised the aforementioned authority and established a fire department and fire regulations for the Village; and

WHEREAS, the Corporate Authorities of the Village have determined that it is necessary, expedient, and in the best interests of the Village and its citizens to amend Chapter 20 (Fire Prevention and Protection), Article II (Fire Department), Section 20-21 (Established; composition) of the Village Code to create the position of Lieutenants of the Fire Department as set forth in this Ordinance.

NOW THEREFORE, BE IT ORDAINED BY THE CORPORATE AUTHORITIES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:

<u>SECTION 1.</u> The Corporate Authorities hereby find that all of the recitals contained in the preamble to this Ordinance are true, correct, and complete and are hereby incorporated by reference hereto and made a part hereof.

SECTION 2. Chapter 20 (Fire Prevention and Protection), Article II (Fire Department), Section 20-21 (Established; composition) is hereby amended to read as follows:

Sec. 20-21. - Established; composition.

- (a) There is hereby created and established a fire department for the Village of Bradley.
- (b) The Bradley Fire Department shall consist of the following:
 - (1) One fire chief;
 - (2) One assistant fire chief;
 - (3) Three lieutenants, promoted in accordance with the terms of any collective bargaining agreement governing such appointment, the Fire Promotion Act, 50 ILCS 742/1, et. seq., and any applicable rules of the Board of Fire and Police Commissioners of the Village of Bradley;
 - (4) Full-time firefighters in such number as approved by the Corporate Authorities of the Village from time to time;

- (5) Paid-on-call firefighters in such number as approved by the Corporate Authorities of the village from time to time;
- (6) Part-time firefighters in such number as approved by the Corporate Authorities of the Village from time to time; and
- (7) Firefighter paramedics in such number as approved by the Corporate Authorities of the Village from time to time.

SECTION 3. In the event that any provision or provisions, portion or portions, or clause or clauses of this Ordinance shall be declared to be invalid or unenforceable by a Court of competent jurisdiction, such adjudication shall in no way affect or impair the validity or enforceability of any of the remaining provisions, portions, or clauses of this Ordinance that may be given effect without such invalid or unenforceable provision or provisions, portion or portions, or clause or clauses.

SECTION 4. That all ordinances, resolutions, motions, or parts thereof, conflicting with any of the provisions of this Ordinance, are hereby repealed to the extent of the conflict.

SECTION 5. That the Village Clerk is hereby directed to publish this Ordinance in pamphlet form.

SECTION 6. That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
