AN ORDINANCE AMENDING CHAPTER 8 (ANIMALS AND FOWL), ARTICLE I (IN GENERAL), SECTION 8-18 (KEEPING CERTAIN ANIMALS PROHIBITED) OF THE CODE OF ORDINANCES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS

WHEREAS, the Corporate Authorities of the Village of Bradley, Kankakee County, Illinois, have the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens; and

WHEREAS, pursuant to Section 11-60-2 of the Illinois Municipal Code (65 ILCS 5/11-60-2) the Corporate Authorities of the Village have authority to define, prevent, and abate nuisances; and

WHEREAS, the Corporate Authorities of the Village previously exercised this authority by enacting the regulations found within Chapter 8 (Animals and Fowl) of the Village Code; and

WHEREAS, the Corporate Authorities of the Village have determined that it is in the best interests of the Village and its citizens to amend Section 8-18 (Keeping Certain Animals Prohibited) to permit Village residents to keep chickens on certain residential properties within the Village, as set forth in this Ordinance; and

WHEREAS, the Corporate Authorities have determined that the keeping of chickens, as permitted by this Ordinance and in full compliance with all other applicable ordinances and regulations in the Village code, will not constitute or create a public nuisance.

NOW THEREFORE, BE IT ORDAINED BY THE CORPORATE AUTHORITIES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:

SECTION 1. The Corporate Authorities hereby find that all of the recitals contained in the preamble to this Ordinance are true, correct, and complete and are hereby incorporated by reference hereto and made a part hereof.

SECTION 2. Chapter 8 (Animals and Fowl), Article I (In General), Section 8-18 (Keeping Certain Animals Prohibited) is hereby amended to read as follows:

Sec. 8-18. - Keeping certain animals prohibited.

(a) It shall be unlawful to keep any live snakes, large cats, swine or pigs, cattle, goats, poultry, fowl or livestock in the village, provided that chickens may be kept only as explicitly permitted by Section 60-25 of this Code. No other animals may be maintained or kept in the village for any purpose other than as pets (except as permitted in pet shops and animal hospitals), and it shall be unlawful to keep or harbor bees in the village.

(b) No person shall cause or allow any stable or place where any animal is or may be kept to become unclean, or unwholesome.

SECTION 3. In the event that any provision or provisions, portion or portions, or clause or clauses of this Ordinance shall be declared to be invalid or unenforceable by a Court of competent jurisdiction, such adjudication shall in no way affect or impair the validity or enforceability of any of the remaining provisions, portions, or clauses of this Ordinance that may be given effect without such invalid or unenforceable provision or provisions, portion or portions, or clause or clauses.

SECTION 4. That all ordinances, resolutions, motions, or parts thereof, conflicting with any of the provisions of this Ordinance, are hereby repealed to the extent of the conflict.

SECTION 5. That the Village Clerk is hereby directed to publish this Ordinance in pamphlet form.

SECTION 6. That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
