ORDINANCE NO. 0-5-20-1

AN ORDINANCE AMENDING ORDINANCE NO. 0-3-20-1 SETTING EMPLOYEE SALARIES

WHEREAS, the Board of Trustees of the Village of Bradley, Kankakee County, Illinois, has the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BY THE BOARD OF TRUSTEES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:

SECTION 1: COMPENSATION OF EXEMPT EMPLOYEES: The Village employees identified on "Attachment A," which is attached hereto and fully incorporated herein, are exempt employees that are not subject to the minimum wage and overtime requirements of existing Illinois and Federal Law. The employees identified on Attachment A shall be entitled to receive an annual salary that falls within the base salary ranges set out in Attachment A.

SECTION 2: AMENDMENT TO ATTACHMENT A: Attachment A is hereby amended to include the position of Fire Chief.

SECTION 3: REPEAL OF PRIOR ORDINANCES: All existing ordinances of the Village of Bradley are hereby repealed insofar as they may be inconsistent with the provisions of this Ordinance. The Clerk of the Village of Bradley shall certify the adoption of this Ordinance.

SECTION 4: In the event that any provision or provisions, or portion or portions of this Ordinance shall be declared to be invalid or unenforceable by a Court of competent jurisdiction, such adjudication shall in no way affect or impair the validity or enforceability of any of the remaining provisions or portions of this Ordinance that may be given effect without such invalid or unenforceable provision or provisions, portion or portions.

SECTION 5: That the Village Clerk is hereby directed to publish this Ordinance in pamphlet form.

SECTION 6: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.

Without the boards insight and approval, I would not have been able to accomplish some of the goals and objectives that were implemented during my brief time with the Village. My only regret is I wish I had more time to give.

In closing if the Board sees fit, I would like to stay on through June 30, 2020 to see a couple of ongoing projects be finalized. During this time, I can assist anyone who will be taking over the position if they would like assistance. If in the future, you need any assistance please feel free to reach out and ask. Even though I will be transitioning back to Bourbonnais Fire on a full-time basis, the District and myself are still expecting to assist the Village of Bradley as we have in the past. Please accept this letter of resignation and my gratitude for a memorable life experience. Lastly, a letter from the District will be forthcoming at the beginning of next week to clarify their intentions to terminate the shared chief position.

As you know, the Village of Bradley's Board of Trustees approved your appointment to the position of Village of Bradley Fire Chief with a start date of Monday, June 15, 2020. We believe your skills and experience are an excellent match for the Village of Bradley and the Bradley Fire Department. You will report directly to the Mayor and Village Administrator.

Your starting salary for this exempt, full-time leadership position is \$110,000 annually to be paid on a biweekly basis concurrent with payroll processing.

While employed in this position, the Village of Bradley will not contribute to a Fire Pension Fund on your behalf, nor will you be eligible to participate.

You are eligible for benefits, which include Health, Dental, Short-term Disability, and Life Insurance. Additional benefits and holiday schedules are outlined in the Village's Personnel Policy.
