AN ORDINANCE AMENDING CHAPTER 30 (OFFENSES AND MISCELLANEOUS PROVISIONS), ARTICLE V (NUISANCES), DIVISION 4 (BUSINESSES AND BUSINESS OPERATIONS), OF THE BRADLEY VILLAGE CODE

WHEREAS, the Corporate Authorities of the Village of Bradley, Kankakee County, Illinois, have the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens; and

WHEREAS, the Illinois General Assembly recently enacted the Cannabis Regulation and Tax Act (410 ILCS 705/1-1, *et seq.*), which *inter alia* legalizes the possession and use of cannabis under certain circumstances; and

WHEREAS, the Village of Bradley previously passed ordinances that regulate and prohibit the possession and use of cannabis where such possession or use would amount to a violation of the Cannabis Control Act (720 ILCS 550/1, *et seq.*) and other applicable Illinois and federal statutes; and

WHEREAS, products containing tetrahydrocannabinol ("THC") such as Delta-8 tetrahydrocannabinol, ("Delta-8 THC"), and Delta-9 tetrahydrocannabinol, ("Delta-9 THC"), are psychoactive substances typically manufactured from hemp-derived cannabidiol ("CBD"); and

WHEREAS, the United States Drug Enforcement Agency has opined that synthetically derived Delta-8 and Delta-9 are illegal controlled substances; and

WHEREAS, Kratom is an herbal substance that can produce opioid and stimulant-like effects and is not presently regulated under the Controlled Substances Act; and

WHEREAS, some municipalities within the State of Illinois have already taken actions banning Kratom within their jurisdiction; and

WHEREAS, the sale of Delta-8 THC, Delta-9 THC, and Kratom, including to minors, is a danger to public health as these products may cause hallucination, vomiting, tremors, anxiety, dizziness, confusion, erratic behavior, aggression, suicidal ideation, psychosis and loss of consciousness, as well as negatively affecting cognitive functioning and even possibly causing death; and

WHEREAS, psychoactive cannabinoids, including Delta-8 THC, Delta-9 THC, and Kratom need to be regulated to protect public health and safety; and,

WHEREAS, the Corporate Authorities of the Village have determined that the sale and distribution of Delta-8 THC, Delta-9 THC, and Kratom within the Village is considered a public nuisance and therefore it is necessary and in the best interests of the Village and its citizens to

amend its ordinances to prohibit the sale and distribution of Delta-8 THC, Delta-9 THC, and Kratom.

NOW THEREFORE, BE IT ORDAINED BY THE CORPORATE AUTHORITIES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:

SECTION 1. The Corporate Authorities hereby find that all the recitals contained in the preamble to this Ordinance are true, correct, and complete and are hereby incorporated by reference hereto and made a part hereof.

SECTION 2. Chapter 30 (Offenses and Miscellaneous Provisions), Article V (Nuisances), Division 4 (Businesses and Business Operations), Section 30-289 (Certain businesses prohibited) is hereby amended with the addition of the bold and underlined text to read as follows:

Sec. 30-289. - Certain businesses prohibited.

- (a) To locate and carry on any packinghouse, renderies, tallow candleries, glue and bone factories, soap factories, tanneries, within the limits of the village and within the distance of one mile outside the village limits is hereby declared to be a nuisance within the village.
- (b) No business operating within the Village of Bradley shall manufacture, sell, offer for sale, give away, deliver, or distribute any products that contain Kratom, Delta-8 THC, Delta-9 THC, or any other novel psychoactive or novel synthetic drug, or a chemical analog of Kratom, Delta-8 THC, Delta-9 THC, or any other novel psychoactive or novel synthetic drug.

SECTION 3. In the event that any provision or provisions, portion or portions, or clause or clauses of this Ordinance shall be declared to be invalid or unenforceable by a Court of competent jurisdiction, such adjudication shall in no way affect or impair the validity or enforceability of any of the remaining provisions, portions, or clauses of this Ordinance that may be given effect without such invalid or unenforceable provision or provisions, portion or portions, or clauses.

SECTION 4. That all ordinances, resolutions, motions, or parts thereof, conflicting with any of the provisions of this Ordinance, are hereby repealed to the extent of the conflict.

SECTION 5. That the Village Clerk is hereby directed to publish this Ordinance in pamphlet form.

SECTION 6. That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
