ORDINANCE NO. O-12-19-1

AN ORDINANCE AMENDING SECTION 4-97, HOURS OF OPERATION OF LICENSED PREMISES OF ARTICLE III, LICENSES, OF CHAPTER 4, ALCOHOLIC BEVERAGES, OF THE VILLAGE OF BRADLEY CODE

WHEREAS, the Board of Trustees of the Village of Bradley, Kankakee County, Illinois, has the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens; and

WHEREAS, pursuant to 235 ILCS 5/4-1 of the Illinois Liquor Control Act of 1934, the president and board of trustees have the power by ordinance or resolution to determine the hours of operation for licensed liquor establishments in the Village of Bradley; and

WHEREAS, the Board of Trustees of the Village of Bradley finds that it is to the public benefit to change the hours of operation of licensed liquor premises to permit the sale, offer for sale at retail, or the giving away of liquor between the hours of 2:00 a.m. and 8:00 a.m. on Sundays.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BY THE BOARD OF TRUSTEES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:

SECTION 1. That the President and Board of Trustees hereby find that all of the recitals contained in the preamble to this Ordinance are true, correct and complete, and further declare that the same are hereby incorporated by reference hereto and made a part hereof.

SECTION 2. That Section 4-97 of Article III of Chapter 4 of the Village is hereby amended as follows:

Sec. 4-97. – Hours of Operation of Licensed Premises.

No person shall sell, permit to be sold, offer for sale at retail, or give away any liquor between the hours of 2:00 a.m. and 6:00 a.m. on Mondays to Saturdays inclusive; nor between the hours of 2:00 a.m. and ~~10:00~~8:00 a.m. on Sundays. Licensees shall close the establishment described in their respective licenses to entrance by the public, at all hours when the retail sale of alcoholic liquors is not authorized. No licensee shall permit patrons to remain in the licensed premises more than 30 minutes after the closing time set forth in this section. The respective time and times above enumerated and set forth are in the time standard prevailing at the date of the sale at retail of alcoholic liquor and on the dates of the changes to and from daylight saving time the early morning closing hours shall be by central standard time.

SECTION 3. That in the event that any section, paragraph, clause, or provision of this Ordinance shall be declared to be invalid or unenforceable by a Court of competent jurisdiction, such adjudication shall in no way affect or impair the validity or enforceability of any of the

remaining sections, paragraphs, clauses, or provisions of this Ordinance that may be given effect without such invalid or unenforceable section or sections, paragraph or paragraphs, clause or clauses, or provision or provisions.

SECTION 4. That all resolutions, ordinances, motions, or parts thereof conflicting with any of the sections, paragraphs, clauses, or provisions of this Ordinance shall be and are hereby repealed to the extent of the conflict.

SECTION 5. That the Village Clerk is hereby directed to publish this Ordinance in pamphlet form.

SECTION 6. That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.

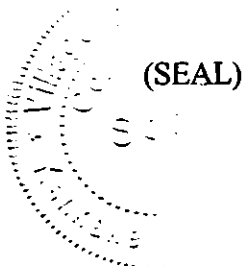
