- 2002 Dodge Neon, blue, VIN# 1B3E546C42D598809 (mileage: unk.)

<u>Section 3.</u> <u>Disposal of Property</u>. The vehicles set forth in Section 2 above shall be disposed of by the Village of Bradley Chief of Police in the manner most beneficial to the Village of Bradley and in accordance with local ordinances and/or state statutes governing same, and upon execution of the Bill of Sale attached hereto where applicable.

<u>Section 4.</u> <u>Severability and Repeal of Inconsistent Ordinances</u>. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance. All existing ordinances of the Village of Bradley are hereby repealed insofar as they may be inconsistent with the provisions of this Ordinance.

<u>Section 5.</u> <u>Effective Date</u>. The Clerk of the Village of Bradley shall certify to the adoption of this Ordinance and shall cause it to be published in pamphlet form and this Ordinance shall take effect upon its approval and publication in pamphlet form as so certified.
