ORDINANCE NO.

AN ORDINANCE AMENDING THE VILLAGE OF BRADLEY CODE OF ORDINANCES TO AUTHORIZE THE TRUSTEES CHAIRPERSON AND MEMBERS OF ALL STANDING AND SPECIAL COMMITTEES

WHEREAS, the Village of Bradley (the "Village") is an Illinois non-home rule municipal corporation located in Kankakee County, Illinois, organized and operating pursuant to the Constitution and laws of the State of Illinois;

WHEREAS, the Trustees may, from time-to-time, have divergent views and perspectives on issues coming before the Village Board due to political, philosophical, and policy-making differences from that of the Village President; and

WHEREAS, the Village currently code is currently silent on allowing Board Members to place matters on the agenda of any meeting of the Village Board; and

WHEREAS, the Trustees may, from time-to-time, have matters of a germane nature to the needs of the Village, which should be presented at Committee, Regular or Special meetings of the Village Board; and

WHEREAS, the Corporate Authorities have determined that it is in the best interests of the Village to empower the Trustees of the Village Board to appoint the chairperson and all members of all standing and special committees of the Village Board.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Bradley, Kankakee County, Illinois, as follows:

<u>SECTION 1</u>. <u>RECITALS</u>.

That the foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.

SECTION 2. APPOINTMENT OF COMMITTEE CHAIRPRESON AND MEMBERS.

Chapter 2 ("Administration"), Article II ("Board of Trustees"), Division 27 ("Committees") of the Village Code of the Village of Bradley shall be, and hereby is, amended by amending sub-section c of Sec. 2-27, as follows:

Sec. 2-201. – COMMITTEES.

All standing and special committees shall consist of <u>between</u> three <u>and six</u> members including the chairperson, unless the board of trustees shall otherwise direct. All committees shall be appointed by the <u>board of trustees</u> <u>village president with the advice and consent of board of trustees</u>.

SECTION 3. RESOLUTION OF CONFLICTS.

All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 4. SAVING CLAUSE.

If any section, paragraph, clause, or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance, which are hereby declared to be separable.

SECTION 5. EFFECTIVENESS.

This Ordinance shall be in full force and effect from and after its passage, approval, and publication in the manner provided by law.
