### ORDINANCE NO. O-6-19-1

AN ORDINANCE AMENDING CHAPTER 2 (ADMINISTRATION), ARTICLE IV (BOARDS, AUTHORITIES, COMMISSIONS AND COMMITTEES), DIVISION 5 (PLANNING AND ZONING COMMISSION), SECTION 2-373 (COMPOSITION AND MEMBERSHIP).

WHEREAS, the Corporate Authorities of the Village of Bradley, Kankakee County, Illinois, have the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens; and

WHEREAS, the Corporate Authorities previously established a Planning and Zoning Commission (the "Commission") for the Village of Bradley; and

WHEREAS, the Corporate Authorities have determined that it is in the best interests of the Village and its citizens to amend Section 2-373 of the Village Code.

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:

<u>SECTION 1.</u> The President and Board of Trustees hereby find that all of the recitals contained in the preamble to this Ordinance are true, correct, and complete and are hereby incorporated by reference hereto and made a part hereof.

<u>SECTION 2.</u> That Chapter 2 (Administration), Article IV (Boards, Authorities, Commissions and Committees), Division 5 (Planning and Zoning Commission), Section 2-373 (Composition and Membership) is hereby amended to read as follows:

# Sec. 2-373. - Composition and membership.

The planning and zoning commission shall consist of seven (7) members who shall be appointed by the village president with the consent of the board of trustees. Each new appointment shall be for a term of five years. All members shall serve with compensation as approved by the board of trustees. The village president shall have the power to remove any member with cause and after a public hearing. The vacancies on the planning and zoning commission shall be filled for the unexpired term of the member whose place has become vacant, in the manner provided herein for appointment of such member.

SECTION 3. In the event that any provision or provisions, portion or portions, or clause or clauses of this Ordinance shall be declared to be invalid or unenforceable by a Court of competent jurisdiction, such adjudication shall in no way affect or impair the validity or enforceability of any of the remaining provisions, portions, or clauses of this Ordinance that may be given effect without such invalid or unenforceable provision or provisions, portion or portions, or clauses.

**SECTION 4.** That all ordinances, resolutions, motions, or parts thereof, conflicting with any of the provisions of this Ordinance, are hereby repealed to the extent of the conflict.

SECTION 5. That the Village Clerk is hereby directed to publish this Ordinance in pamphlet form.

<u>SECTION 6.</u> That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
