AN ORDINANCE AUTHORIZING A MEMORANDUM OF UNDERSTANDING BETWEEN THE VILLAGE OF BRADLEY, THE KANKAKEE COUNTY CONVENTION & VISITOR'S BUREAU, INC., AND ZAGSTER, INC.

WHEREAS, the President and Board of Trustees of the Village of Bradley, Kankakee County, Illinois, have the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens; and

WHEREAS, the Kankakee County Convention & Visitor's Bureau, Inc. ("KCCVB"), desires to enter into an agreement with Zagster, Inc. ("Zagster"), to provide a bikeshare system (the "Bikeshare Program") for Kankakee County; and

WHEREAS, the KCCVB has requested that the Village enter into a Memorandum of Understanding ("MOU") with the KCCVB and Zagster, and in so doing to sponsor the installation, maintenance, and use of ten (10) bicycles and two (2) bicycle racks within the corporate limits of the Village as part of the Bikeshare Program; and

WHEREAS, a copy of the proposed MOU is attached hereto as Exhibit A and fully incorporated herein; and

WHEREAS, the Village desires to sponsor the Bikeshare Program, as set forth in the MOU; and

WHEREAS, the President and Board of Trustees of the Village have determined that sponsoring the Bikeshare Program, as set forth in the MOU, is in the best interests of the Village and its citizens.

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:

<u>SECTION 1.</u> The President and Board of Trustees hereby find that all of the recitals contained in the preamble to this Ordinance are true, correct, and complete and are hereby incorporated by reference hereto and made a part hereof.

<u>SECTION 2.</u> That the President and Board of Trustees of the Village hereby adopt the Memorandum of Understanding ("MOU") attached hereto as Exhibit A and fully incorporated herein.

SECTION 3. That the Village President is hereby authorized and directed, in his capacity as such President, to execute the MOU on behalf of the Village.

SECTION 4. That the Village President is further authorized and directed to take any other action and execute any other documents necessary to allow the Village to sponsor the Bikeshare Program as set forth in the MOU.

SECTION 5. In the event that any provision or provisions, portion or portions, or clause or clauses of this Ordinance shall be declared to be invalid or unenforceable by a Court of competent jurisdiction, such adjudication shall in no way affect or impair the validity or enforceability of any of the remaining provisions, portions, or clauses of this Ordinance that may be given effect without such invalid or unenforceable provision or provisions, portion or portions, or clause or clauses.

SECTION 6. That all ordinances, resolutions, motions, or parts thereof, conflicting with any of the provisions of this Ordinance, are hereby repealed to the extent of the conflict.

SECTION 7. That the Village Clerk is hereby directed to publish this Ordinance in pamphlet form.

SECTION 8. That this Ordinance shall be in full force and effect from and after its
