ORDINANCE NO. 0-10-20-4

AN ORDINANCE RENAMING LOWE'S BOULEVARD TO PROGRESSIVE WAY IN THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS

WHEREAS, the Corporate Authorities of the Village of Bradley, Kankakee County, Illinois, have the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens; and

WHEREAS, pursuant to 65 ILCS 5/11-80-19 of the Illinois Municipal Code, the Corporate Authorities of the Village may change the name of any street, avenue, alley, or other public place under the Village's jurisdiction; and

WHEREAS, it is in the best interest of the Village and its citizens that Lowe's Boulevard, as depicted on the attached Exhibit A, be renamed Progressive Way; and

WHEREAS, this change in the name from Lowe's Boulevard to Progressive Way shall be effective thirty (30) days after the Village notifies the election authorities having jurisdiction in the area and the post office branch serving that area in writing by certified or registered mail.

NOW THEREFORE, BE IT ORDAINED BY THE CORPORATE AUTHORITIES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:

<u>SECTION 1.</u> The Corporate Authorities hereby find that all of the recitals contained in the preamble to this Ordinance are true, correct, and complete and are hereby incorporated by reference hereto and made a part hereof.

SECTION 2. Lowe's Boulevard, as depicted on the attached Exhibit A, is hereby renamed "Progressive Way."

SECTION 3. The Village Clerk is hereby directed to provide notice of this Ordinance to the election authorities with jurisdiction over and the post office(s) serving the area surrounding the newly-renamed Progressive Way. Such notice shall be provided by mailing a certified copy of this Ordinance by certified mail, return receipt requested.

SECTION 4. In the event that any provision or provisions, portion or portions, or clause or clauses of this Ordinance shall be declared to be invalid or unenforceable by a Court of competent jurisdiction, such adjudication shall in no way affect or impair the validity or enforceability of any of the remaining provisions, portions, or clauses of this Ordinance that may be given effect without such invalid or unenforceable provision or provisions, portion or portions, or clauses.

<u>SECTION 5.</u> That all ordinances, resolutions, motions, or parts thereof, conflicting with any of the provisions of this Ordinance, are hereby repealed to the extent of the conflict.

SECTION 6. That the Village Clerk is hereby directed to publish this Ordinance in pamphlet form.

SECTION 7. That this Ordinance shall be in full force and effect thirty (30) days after the Village Clerk notifies the applicable election authorities and post office(s) of the name change affected hereby.


