THE 2021 PROPERTY TAX LEVY ORDINANCE

WHEREAS, the President and Board of Trustees of the Village of Bradley, Kankakee County, Illinois, did on April 30, 2021, pass and adopt the annual Budget Ordinance for the Village of Bradley, Illinois (hereinafter "Village") for the fiscal year of the Village beginning on the 1st day of May, 2021, and ending on the 30th day of April, 2022, being Ordinance Number O-4-21-3.

NOW THEREFORE, BE IT ORDAINED BY THE CORPORATE AUTHORITIES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:

<u>SECTION 1. Recitals Incorporated</u>. The above recitals are incorporated into this Ordinance and shall have the same force and effect as though fully set forth herein.

<u>SECTION 2. Tax Levy</u> Taxes are hereby levied upon all taxable property within the Village of Bradley for the fiscal year ending April 30, 2022, for the following specific purposes:

<u>Section 3.Unexpired Appropriations.</u> All unexpired appropriations for the fiscal year ending April 30, 2021, are continued for the purpose for which they were appropriated and levied.

<u>Section 4. Assessment of Tax Levy.</u> The total amount of Three Million Three Hundred Ninety Three Thousand Two Hundred Sixty Dollars and 00/100 (\$3,393,260.00) ascertained above, is hereby levied and assessed on all property subject to taxation within the Village according to the value of said property as assessed and equalized for the current year.

Section 5. Certification to County Clerk. There is hereby certified to the County Clerk of Kankakee County, Illinois, the several sums above, constituting said total amount, in the total amount of, Three Million Three Hundred Ninety Three Thousand Two Hundred Sixty Dollars and 00/100 (\$3,393,260.00) which total amount the Village requires to be raised by taxation for the 2021/2022 fiscal year of the Village, and the Village Clerk of the Village is hereby ordered and directed to file with the County Clerk of the County of Kankakee on or before the last Tuesday of December, 2021 a certified copy of this Ordinance.

<u>Section 6. Severability and Repeal of Inconsistent Ordinances</u>. Any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance. All existing ordinances of the Village of Bradley are hereby repealed insofar as they may be inconsistent with the provisions of this Ordinance.

<u>Section 7. Effective Date.</u> The Clerk of the Village of Bradley shall certify to the adoption of this Ordinance and shall cause it to be published in pamphlet form, and this Ordinance shall take effect upon its approval and publication in pamphlet form as so certified.

Brief Summary: On 1/27/20 the Village Board passed Resolution 1-20-3 "Proclaiming the Village of Bradley's Intent to Earmark Revenue from Sales Taxes for the Purpose of Granting Property Tax Relief, Expenditure of Public Infrastructure, and Supporting Municipal Operations." The Village's Non-home Rule sales Tax has revenue has exceeded the original projections and in spirit with Resolution the Village Board can refund 100% of property taxes received from Tax Levy Year 2021. The Village will levy \$3,393,260 and abate the two GO Bonds (2015A Sewer Bonds and 2021 Pension Obligations bonds) for a net amount of \$2,262,160, which also coincides with the exact amount that was levied for tax year 2019. Tax bills in Kankakee County are typically sent out beginning in June with the second and final payment due in October. The Village will implement a rebate program to all residents and businesses to refund them 100% of the Villages portion of property taxes paid. The rebate form will be a simple form to fill out and will require basic information such as name, address, real estate pin #, proof of payment and certification that they have are entitled to the refund. Applications will be going out shortly so that the residents and businesses become familiar with form. We will begin to process refunds in October of 2022. Staff recommends that the Village Board approve the proposed tax levy ordinance, fully abate the 2015A & 2021 GO Bonds as well as direct Staff to prepare for a 100% property tax rebate.
