**ORDINANCE NO. O-11-19-7**

**THE 2019 PROPERTY TAX LEVY ORDINANCE**

**WHEREAS**, the President and Board of Trustees of the Village of Bradley, Kankakee County, Illinois, did on April 29, 2019, pass and adopt the annual Budget Ordinance for the Village of Bradley, Illinois (hereinafter “Village”) for the fiscal year of the Village beginning on the 1st day of May, 2019, and ending on the 30th day of April, 2020, being Ordinance Number O-4-19-9.

**NOW, THEREFORE, BE IT AND IT IS HEREBY ORDAINED** by the President and Board of Trustees of the Village of Bradley, Kankakee County, Illinois, as follows:

Section 1.     Recital Incorporated. The above recital is incorporated into this Ordinance and shall have the same force and effect as though fully set forth herein.

Section 2.     Tax Levy. Taxes are hereby levied upon all taxable property within the Village of Bradley for the fiscal year ending April 30, 2020, for the following specific purposes:

**Section 4. Unexpired Appropriations.** All unexpired appropriations for the fiscal year ending April 30, 2019, are continued for the purpose for which they were appropriated and levied.

**Section 5. Assessment of Tax Levy.** The total amount of Two Million Six Hundred Sixty Two Thousand Two Hundred Sixty and 00/100 Dollars (\$2,662,260.00) ascertained above, is hereby levied and assessed on all property subject to taxation within the Village according to the value of said property as assessed and equalized for the current year.

**Section 6. Certification to County Clerk.** There is hereby certified to the County Clerk of Kankakee County, Illinois, the several sums above, constituting said total amount, in the total amount of Two Million Six Hundred Sixty Two Thousand Two Hundred Sixty Dollars and 00/100 (\$2,662,260.00), which total amount the Village requires to be raised by taxation for the 2019/2020 fiscal year of the Village, and the Village Clerk of the Village is hereby ordered and directed to file with the County Clerk of the County of Kankakee on or before the last Tuesday of December, 2019 a certified copy of this Ordinance.

**Section 7. Severability and Repeal of Inconsistent Ordinances.** Any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance. All existing ordinances of the Village of Bradley are hereby repealed insofar as they may be inconsistent with the provisions of this Ordinance.

**Section 8. Effective Date.** The Clerk of the Village of Bradley shall certify to the adoption of this Ordinance and shall cause it to be published in pamphlet form, and this Ordinance shall take effect upon its approval and publication in pamphlet form as so certified.
