**A RESOLUTION ACCEPTING BIDS FOR EARTHWORK IN CONNECTION WITH
THE BRADLEY SPORTS COMPLEX**

WHEREAS, the Corporate Authorities of the Village of Bradley, Kankakee County, Illinois, have the authority to adopt resolutions and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens; and

WHEREAS, on or around March 8, 2024, the Village published an advertisement for bids for earthwork for the pending Bradley Sports Complex Project (the “Project”); and

WHEREAS, the Village opened and reviewed all bids received in relation to the Project on April 3, 2024; and

WHEREAS, the Corporate Authorities of the Village have determined that Tenco Excavating, Inc. (herein after referred to as the “Vendor”) was the lowest responsible bidders for the Project; and

WHEREAS, the Corporate Authorities of the Village have determined that it is necessary, expedient, and in the best interests of the Village and its citizens to accept the bid for earthwork for the Bradley Sports Complex Project, in the total amount of three million two hundred thirteen thousand one hundred twenty five dollars and 00/100 (\$3,213,125.00) for earthwork construction in connection with the Project (a copy of the bid tabulation is attached hereto as Exhibit A and fully incorporated herein); and

NOW THEREFORE, BE IT RESOLVED BY THE CORPORATE AUTHORITIES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:

SECTION 1. The Corporate Authorities hereby find that all of the recitals contained in the preamble to this Resolution are true, correct, and complete and are hereby incorporated by reference hereto and made a part hereof.

SECTION 2. The Corporate Authorities of the Village hereby find and declare that the bid received by from Tenco Excavating, Inc. for the earthwork construction contract in connection with the Project, is fair, reasonable, and acceptable to the Village and hereby awards said contract to Tenco Excavating, Inc. For the total amount of three million two hundred thirteen thousand one hundred twenty five dollars and 00/100 (\$3,213,125.00)

SECTION 3. The Corporate Authorities of the Village hereby authorize and direct the Village President to take any actions necessary to effectuate the intent of this Resolution, which is to accept the bid from the vendor for the Project and to award the vendor the respective contract.

SECTION 4. In the event that any provision or provisions, portion or portions, or clause or clauses of this Resolution shall be declared to be invalid or unenforceable by a Court of competent

jurisdiction, such adjudication shall in no way affect or impair the validity or enforceability of any of the remaining provisions, portions, or clauses of this Resolution that may be given effect without such invalid or unenforceable provision or provisions, portion or portions, or clause or clauses.

SECTION 5. All ordinances, resolutions, motions, or parts thereof, conflicting with any of the provisions of this Resolution, are hereby repealed to the extent of the conflict.

SECTION 6. The Village Clerk is hereby directed to publish this Resolution in pamphlet form.

SECTION 7. This Resolution shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.


