

RESOLUTION NO. R-3-14-2

A RESOLUTION AMENDING THE AMOUNT OF FUNDS PREVIOUSLY APPROPRIATED FOR IMPROVEMENTS TO THE INTERSECTION OF ILLINOIS 50 (KINZIE AVENUE) AND LARRY POWER ROAD

WHEREAS, the Village of Bradley of Kankakee, County, Illinois, hereinafter called "Village," and the State of Illinois, through its Department of Transportation, hereinafter called the "State," previously entered into a formal agreement ("Agreement") related to the sharing of certain costs for improving the intersection of Illinois 50 (Kinzie Avenue) and Larry Power Road (R-9-12-1, adopted 9/24/12); and

WHEREAS, the subject project is identified under Illinois 50 (FAP 840), State Section (140)N, TS-3, Construction # C-93-128-12 and Contract # 66C32; and

WHEREAS, the Village previously appropriated \$88,000.00 as an estimated share of its cost (R-9-12-1, adopted 9/24/12); and

WHEREAS, in recognition of the fact that Bradley's actual monetary obligation would be based upon the final bid unit prices of the awarded contract, the Village previously agreed to pass and adopt a supplemental resolution to provide additional funds if the amount (\$88,000.00) set forth in §4 of R-9-12-1 proved to be insufficient to cover its share of costs; and

WHEREAS, the Illinois Department of Transportation has recently adjusted its total project construction cost, and the updated share of cost to the Village for the proposed intersection improvement is approximately \$115,000.00; and

WHEREAS, in compliance with the aforementioned Agreement, it is necessary for the Village to amend its amount of appropriated funds to pay the local share of costs for the subject project;

NOW THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of Bradley, as follows:

Section 1. Recitals Incorporated. The above recitals are incorporated herein as though fully set forth.

Section 2. Appropriation of Funds. The Village hereby amends its original appropriation (R-9-12-1) and now appropriates the sum of One Hundred and Fifteen Thousand Dollars (\$115,000.00), which represents Bradley's share of the costs for the improvement of the Illinois 50 and Larry Power Road intersection.

Section 3. Supplemental Resolution. In accordance with the Agreement, Bradley agrees to pass and adopt a supplemental resolution to provide additional funds if the amount set forth in Section 2 above proves to be insufficient to cover its share of costs.

Section 4. Severability and Repeal of Inconsistent Resolutions. If any section, paragraph, clause or provision of this Resolution shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Resolution. All resolutions, ordinances and motions in conflict herewith are hereby repealed to the extent of such conflict.

Section 5. Effective Date. This Resolution shall take effect from and after its adoption and approval.


