A RESOLUTION APPROVING THE EXTENSION OF AN INTERGOVERNMENTAL AGREEMENT (Shared Employment)

WHEREAS, Article VII, Section 10 of the Constitution of the State of Illinois of 1970 provides that units of local government may contract or otherwise associate among themselves to obtain or share services and to exercise, combine, or transfer any power or function in any manner not prohibited by law or by ordinance; and

WHEREAS, Section 220/5 of the Intergovernmental Cooperation Act provides that any one or more public agencies may contract with any one or more other public agencies to perform any governmental service which any of the public agencies is authorized by law to perform, provided the contract is authorized by the governing body of each party to the contract; Chapter 5 ILCS 220/1-8; and

WHEREAS, The Village of Bradley maintains a fire department pursuant to the authority granted under 65 ILCS 5/11-6-1 of the Illinois Municipal Code; and

WHEREAS, The Village of Bradley entered into an Intergovernmental Agreement with the Bourbonnais Fire Protection District; and

WHEREAS, The Village of Bradley has determined that it is in its best interests to extend the timeframe of the attached Intergovernmental Agreement ("Intergovernmental Agreement") with the Bourbonnais Fire Protection District.

NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, BY AND PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:

- SECTION 1. The Village President and Board of Trustees hereby find that all of the recitals contained in the preamble to this Resolution are true, correct and complete and are hereby incorporated by reference thereto and made a part hereof.
- <u>SECTION 2.</u> The attached Intergovernmental Agreement between the Village of Bradley and the Bourbonnais Fire Protection District is hereby approved, and the Village President is authorized to execute said Intergovernmental Agreement on behalf of the Village of Bradley.
- **SECTION 3.** This Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.
- SECTION 4. In the event that any provision or provisions, portion or portions, or clause or clauses of this Resolution shall be declared to be invalid or unenforceable by a Court of competent jurisdiction, such adjudication shall in no way affect or impair the validity or enforceability of any

of the remaining provisions, portions, or clauses of this Resolution that may be given effect without such invalid or unenforceable provision or provisions, portion or portions, or clause or clauses.

SECTION 5. All ordinances, resolutions, motions, or parts thereof, conflicting with any of the provisions of this Resolution, are hereby repealed to the extent of the conflict.

SECTION 6. The Village Clerk is hereby directed to publish this Resolution in pamphlet form.

<u>SECTION 7.</u> This Resolution shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.
