**A RESOLUTION PROCLAIMING THE RESULTS OF THE
CONSOLIDATED ELECTION HELD WITHIN THE VILLAGE OF BRADLEY,
KANKAKEE COUNTY, ILLINOIS ON THE 1ST DAY OF APRIL, 2025**

WHEREAS, the Corporate Authorities of the Village of Bradley, Kankakee County, Illinois, have the authority to adopt resolutions and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens; and

WHEREAS, a consolidated election was conducted in the Village of Bradley, Kankakee County, Illinois, on the first (1st) day of April, 2025, for the purpose of electing a village president, a village clerk, and three village trustees; and

WHEREAS, the election was called in accordance with law, the votes were cast, and the Kankakee County Clerk has canvassed the votes and declared and proclaimed the results of the election; and

WHEREAS, the Corporate Authorities of the Village of Bradley desire to proclaim and declare the results of the consolidated election so that the results are included in the permanent records of the Village of Bradley.

NOW THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:

SECTION 1. The Corporate Authorities hereby find that all of the recitals contained in the preamble to this Resolution are true, correct, and complete and are hereby incorporated by reference hereto and made a part hereof.

SECTION 2. The Village has received copies of the following documents from Kankakee County Clerk:

- (1) Certificate of Canvass Results; and
- (2) Statement of Votes Cast; and
- (3) Abstract of Votes.

All three of the aforementioned documents are attached hereto as Group Exhibit A and fully incorporated herein. Hereinafter the documents included in Group Exhibit A shall be referred to as the "Election Results."

SECTION 3. As indicated in the Election Results, the Kankakee County Clerk certified the results of the April 1, 2025 consolidated election on April 15, 2025, and at that time declared

and proclaimed that the total number of ballots requested and received for such election is eight hundred forty (840).

SECTION 4. As indicated in the Election Results, the Kankakee County Clerk canvassed the votes for the election of one (1) person to the office of Village President in the Village of Bradley. Michael "Mike" Watson received seven hundred twenty-nine (729) votes. Michael "Mike" Watson was declared and proclaimed the winner of the election and has been elected to serve as Village President.

SECTION 5. As indicated in the Election Results, the Kankakee County Clerk canvassed the votes for the election of one (1) person to the office of Village Clerk. Kelli Brza received seven hundred eighteen (718) votes. Kelli Brza was declared and proclaimed the winner of the election and has been elected to serve as Village Clerk.

SECTION 6. As indicated in the Election Results, the Kankakee County Clerk canvassed the votes for the election of three (3) persons to the office of Village Trustee. Ryan LeBran received six hundred twenty-five (625) votes. Brian Tieri received six hundred three (603) votes. Grant D. Vandenhout received five hundred ninety-five (595) votes. Ryan LeBran, Brian Tieri, and Grant D. Vandenhout were declared and proclaimed the winners of the election and have been elected to serve as Village Trustees.

SECTION 7. In the event that any provision or provisions, portion or portions, or clause or clauses of this Resolution shall be declared to be invalid or unenforceable by a Court of competent jurisdiction, such adjudication shall in no way affect or impair the validity or enforceability of any of the remaining provisions, portions, or clauses of this Resolution that may be given effect without such invalid or unenforceable provision or provisions, portion or portions, or clause or clauses.

SECTION 8. All ordinances, resolutions, motions, or parts thereof, conflicting with any of the provisions of this Resolution, are hereby repealed to the extent of the conflict.

SECTION 9. The Village Clerk is hereby directed to publish this Resolution in pamphlet form.

SECTION 10. This Resolution shall be in full force and effect immediately upon its passage.
