**WHEREAS**, the Village Clerk corrected the Meeting minutes to reflect that the newly elected Village officials were sworn into office (a copy of the corrected minutes is attached hereto as Exhibit A and fully incorporated herein); and

WHEREAS, the Corporate Authorities of the Village have determined that it is in the best interests of the Village and its citizens approve the corrected the Meeting minutes to reflect that the newly elected Village officials were sworn into office.

NOW THEREFORE, BE IT RESOLVED BY THE CORPORATE AUTHORITIES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:
