# A RESOLUTION AUTHORIZING THE AWARD OF THE VILLAGE'S 2020 CURB AND SIDEWALK CONTRACT TO

WHEREAS, the Corporate Authorities of the Village of Bradley, Kankakee County, Illinois, have the authority to adopt resolutions and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens; and

WHEREAS, on July 14, 2020, the Village published an invitation to bid on its proposed 2020 Curb and Sidewalk Program contract (the "Contract"); and

WHEREAS, the Village accepted and received sealed bids for the Contract between July 14, 2020, and July 24, 2020, at 10:00 am, at which time all such bids received were opened and publicly read aloud; and

WHEREAS, the Corporate Authorities of the Village have determined that Davis

(the "Contractor") is the lowest responsible bidder for the Project, having bid a total amount of \$ 107, 291.00; and

WHEREAS, the Corporate Authorities of the Village have determined that it is in the best interests of the Village and its citizens to award the Contract to the Contractor.

NOW THEREFORE, BE IT RESOLVED BY THE CORPORATE AUTHORITIES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:

<u>SECTION 1.</u> The Corporate Authorities hereby find that all of the recitals contained in the preamble to this Resolution are true, correct, and complete and are hereby incorporated by reference hereto and made a part hereof.

SECTION 3. In the event that any provision or provisions, portion or portions, or clause or clauses of this Resolution shall be declared to be invalid or unenforceable by a Court of competent jurisdiction, such adjudication shall in no way affect or impair the validity or enforceability of any of the remaining provisions, portions, or clauses of this Resolution that may be given effect without such invalid or unenforceable provision or provisions, portion or portions, or clauses.

<u>SECTION 4.</u> All ordinances, resolutions, motions, or parts thereof, conflicting with any of the provisions of this Resolution, are hereby repealed to the extent of the conflict.

SECTION 5. The Village Clerk is hereby directed to publish this Resolution in pamphlet form. SECTION 6. This Resolution shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.
