**A RESOLUTION AWARDING THE 2023 SANITARY SEWER CLEANING AND  
TELEVISIONING CONTRACT TO VISU-SEWER OF ILLINOIS**

**WHEREAS**, the Corporate Authorities of the Village of Bradley, Kankakee County, Illinois, have the authority to adopt resolutions and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens; and

**WHEREAS**, pursuant to Section 2-3-8 of the Illinois Municipal Code (65 ILCS 5/2-3-8), the corporate authorities of the Village are authorized to enter into contracts for any legitimate governmental purpose; and

**WHEREAS**, the Village previously advertised for and received bids in relation to the Village's 2023 Sanitary Sewer Cleaning and Televisioning project (the "Project"); and

**WHEREAS**, the Village opened all received bids on March 22, 2023, at which time it was determined that Visu-Sewer of Illinois (the "Company") was the lowest bidder with a bid of one hundred fifteen thousand four and 30/100 dollars (\$115,004.30); and

**WHEREAS**, the Corporate Authorities of the Village have determined that it is necessary, expedient, and in the best interests of the Village and its citizens to award the contract for the Project to the Company in an amount not to exceed one hundred fifteen thousand four and 30/100 dollars (\$115,004.30), as set forth herein.

**NOW THEREFORE, BE IT RESOLVED BY THE CORPORATE AUTHORITIES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:**

**SECTION 1.** The Corporate Authorities hereby find that all of the recitals contained in the preamble to this Resolution are true, correct, and complete and are hereby incorporated by reference hereto and made a part hereof.

**SECTION 2.** The Corporate Authorities hereby find and declare that the Company is the lowest responsible bidder on the Project. Therefore, the Corporate Authorities hereby award the contract for the Project to the Company. The Corporate Authorities further authorize and direct the Village President to enter into a contract with the Company in connection with the Project for a maximum price not to exceed one hundred fifteen thousand four and 30/100 dollars (\$115,004.30), and further to take any actions, including the signing and delivery of any documents, necessary to effectuate the intent of this Resolution.

**SECTION 3.** In the event that any provision or provisions, portion or portions, or clause or clauses of this Resolution shall be declared to be invalid or unenforceable by a Court of competent jurisdiction, such adjudication shall in no way affect or impair the validity or enforceability of any of the remaining provisions, portions, or clauses of this Resolution that may be given effect without such invalid or unenforceable provision or provisions, portion or portions, or clause or clauses.

**SECTION 4.** All ordinances, resolutions, motions, or parts thereof, conflicting with any of the provisions of this Resolution, are hereby repealed to the extent of the conflict.

**SECTION 5.** The Village Clerk is hereby directed to publish this Resolution in pamphlet form.

**SECTION 6.** This Resolution shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.

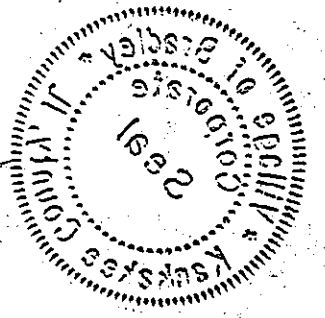

We have reviewed the bids received on March 22, 2023 for the referenced project, and find them to be as follows:

Visu-Sewer of Illinois	\$115,004.30
Hydro-Vision Technology	\$153,220.50
National Power Rodding Corporation	\$179,750.00

As seen on the enclosed itemized bid tabulation, the low bid is approximately 4.24% lower than the estimated cost of \$120,106.50.
