A RESOLUTION COMMITTING LOCAL FUNDS FOR CDBG SECTION IV HOUSING REHABILITATION COMPONENT GRANT FUNDING

WHEREAS, the Village Board of the Village of Bradley, Illinois has taken action to submit an Illinois Community Development Block Grant (CDBG) Program housing rehabilitation application, and

WHEREAS, receipt of CDBG grant assistance is essential to allow the Village of Bradley to undertake the project to rehabilitate structural deficiencies of 10 or more homes of low-to-moderate income households in the designated project area, and

WHEREAS, criteria of CDBG are such that financial participation by the grantee is required in conjunction with CDBG funds,

WHEREAS, the Village of Bradley has certain monies allocated for the above-referenced project with cash on hand, as needed.

NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:

The Village of Bradley does hereby commit funds from the General Fund/Community Development Department for use in conjunction with an Illinois Community Development Block Grant Program, such funds to equal 3.5% of the estimated total project cost of \$570,000, or \$20,000.

This Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.

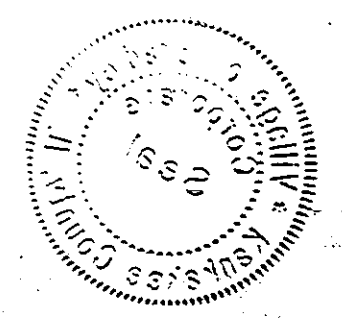



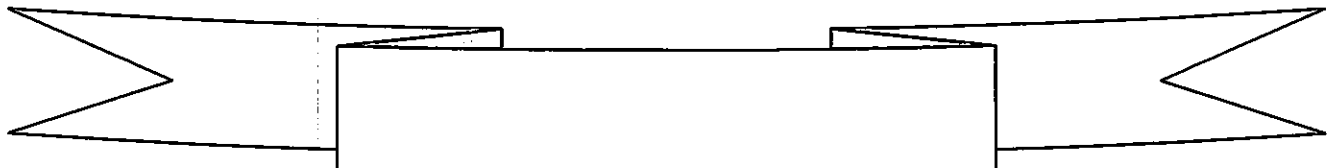
