## A RESOLUTION DENYING THE FINAL PLAT OF SUBDIVISION FOR THE BRADLEY POINTE SUBDIVISION

- WHEREAS, the Corporate Authorities of the Village of Bradley, Kankakee County, Illinois, have the authority to adopt resolutions and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens; and
- **WHEREAS**, William Lemna (the "Owner") is the owner of certain property (depicted on Exhibit A to this Resolution) located within the corporate boundaries of the Village of Bradley (the "Subject Property"); and
- **WHEREAS**, on January 25, 2023, the Owner filed an application with the Village seeking the approval of a Final Plat of subdivision for the Subject Property (the "Plat") (the Plat is attached hereto as Exhibit A and fully incorporated herein); and
- **WHEREAS**, on April 4, 2023, the Village Planning and Zoning Commission ("Plan Commission") considered the Owner's application and request and recommended that the Corporate Authorities of the Village deny and reject the Plat; and
- WHEREAS, the Corporate Authorities hereby accept and adopt the recommendation of the Plan Commission and determine that the Plat is inconsistent with the comprehensive plan and subdivision ordinances of the Village; and
- **WHEREAS**, the Corporate Authorities have determined that it is in the best interests of the Village and its citizens to deny and reject the Plat.
- NOW THEREFORE, BE IT RESOLVED BY THE CORPORATE AUTHORITIES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:
- **SECTION 1.** The Corporate Authorities hereby find that all of the recitals contained in the preamble to this Resolution are true, correct, and complete and are hereby incorporated by reference hereto and made a part hereof.
- <u>SECTION 2.</u> The Corporate Authorities of the Village hereby deny and reject the Plat (<u>Exhibit A</u>). The Village Clerk is hereby authorized and directed to transmit a copy of this Resolution to the Owner.
- SECTION 3. In the event that any provision or provisions, portion or portions, or clause or clauses of this Resolution shall be declared to be invalid or unenforceable by a Court of competent jurisdiction, such adjudication shall in no way affect or impair the validity or enforceability of any of the remaining provisions, portions, or clauses of this Resolution that may be given effect without such invalid or unenforceable provision or provisions, portion or portions, or clause or clauses.

**SECTION 4.** All ordinances, resolutions, motions, or parts thereof, conflicting with any of the provisions of this Resolution, are hereby repealed to the extent of the conflict.

**SECTION 5.** The Village Clerk is hereby directed to publish this Resolution in pamphlet form.

<u>SECTION 6.</u> This Resolution shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.


