A RESOLUTION WAIVING COMPETITIVE BIDDING AND APPROVING THE PURCHASE OF AN ADVANCED LIFE SUPPORT AMBULANCE FROM AMERICAN RESPONSE VEHICLES, INC., IN AN AMOUNT NOT TO EXCEED \$237,000.00

## A RESOLUTION WAIVING COMPETITIVE BIDDING AND APPROVING THE PURCHASE OF AN ADVANCED LIFE SUPPORT AMBULANCE FROM AMERICAN RESPONSE VEHICLES, INC., IN AN AMOUNT NOT TO EXCEED \$237,000.00

- WHEREAS, the Corporate Authorities of the Village of Bradley, Kankakee County, Illinois, have the authority to adopt resolutions and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens; and
- WHEREAS, pursuant to 65 ILCS 5/2-3-8, the Corporate Authorities of the Village of Bradley are authorized to enter into contracts that serve the legitimate public purposes of the Village; and
- **WHEREAS**, pursuant to 65 ILCS 5/11-6-1, the Village of Bradley is authorized to operate, and does operate, a fire department; and
- WHEREAS, the Corporate Authorities of the Village have determined that it is necessary, expedient, and in the best interests of the Village and its citizens to purchase and operate a new Advanced Life Support Ambulance (the "Ambulance"); and
- WHEREAS, American Response Vehicles, Inc. (the "Vendor"), is a Missouri corporation authorized to conduct business in the state of Illinois and having a business office located at 36289 North Falcon Drive, Ingleside, Illinois 60041; and
- WHEREAS, the Vendor is in the business of selling emergency vehicles, including without limitation Ambulances, and presently has an Ambulance for sale; and
- WHEREAS, the Public Safety Committee of the Village Board of Trustee's considered the need to purchase the Ambulance on August 8, 2022, and there and then recommended that the Corporate Authorities of the Village authorize the purchase thereof from the Vendor.
- WHEREAS, the Corporate Authorities of the Village have determined that it is in the best interests of the Village and its citizens to purchase the Ambulance from the Vendor; and
- WHEREAS, the Corporate Authorities of the Village have, by the affirmative vote of two-thirds (2/3) of all Village Trustees presently holding office, determined that it is necessary, expedient, and in the best interests of the Village and its citizens to waive any and all competitive bidding requirements as might otherwise be applicable to the purchase of the Ambulance by the Village.

## NOW THEREFORE, BE IT RESOLVED BY THE CORPORATE AUTHORITIES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:

- <u>SECTION 1.</u> The Corporate Authorities hereby find that all of the recitals contained in the preamble to this Resolution are true, correct, and complete and are hereby incorporated by reference hereto and made a part hereof.
- SECTION 2. The Fire Chief of the Village of Bradley is hereby authorized and directed to undertake any and all actions, including without limitation executing and delivering any and all documents, as may be necessary to purchase the Ambulance from the Vendor, provided that the total cost authorized for the purchase shall not exceed \$237,000.00.
- SECTION 3. The Corporate Authorities hereby waive, by the affirmative vote of two-thirds (2/3) of all Village Trustees presently holding office, any and all competitive bidding requirements as might otherwise be applicable to the purchase of the Ambulance authorized by this Resolution.
- SECTION 4. In the event that any provision or provisions, portion or portions, or clause or clauses of this Resolution shall be declared to be invalid or unenforceable by a Court of competent jurisdiction, such adjudication shall in no way affect or impair the validity or enforceability of any of the remaining provisions, portions, or clauses of this Resolution that may be given effect without such invalid or unenforceable provision or provisions, portion or portions, or clauses.
- SECTION 5. All ordinances, resolutions, motions, or parts thereof, conflicting with any of the provisions of this Resolution, are hereby repealed to the extent of the conflict.
- **SECTION 6.** The Village Clerk is hereby directed to publish this Resolution in pamphlet form.
- **SECTION 7.** This Resolution shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.
