# A RESOLUTION AWARDING THE LIL'S PARK PARKING LOT EXPANSION CONTRACT TO HAMANN WAGNER EXCAVATING, INC

WHEREAS, the Corporate Authorities of the Village of Bradley, Kankakee County, Illinois, have the authority to adopt resolutions and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens; and

WHEREAS, the Corporate Authorities of the Village desire to commence work on the expansion of the parking lot at Lil's Park (the "Project"); and

WHEREAS, after appropriate advertisement, bids for the project were opened on December 12, 2022, and Hamann Wagner Excavating, Inc. was the lowest responsible bidder, having bid in the amount of seventy-seven thousand two-hundred ninety-five and 55/100 dollars (\$77,295.55); and

WHEREAS, the Corporate Authorities of the Village have determined that it is in the best interests of the Village and its citizens to award the contract for the Project to Hamann Wagner Excavating, Inc.

NOW THEREFORE, BE IT RESOLVED BY THE CORPORATE AUTHORITIES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:

<u>SECTION 1.</u> The Corporate Authorities hereby find that all of the recitals contained in the preamble to this Resolution are true, correct, and complete and are hereby incorporated by reference hereto and made part hereof.

SECTION 2. The Corporate Authorities of the Village hereby award the contract for the expansion of the parking lot at Lil's Park (the "Project"), to Hamann Wagner Excavating, Inc. in the total amount of seventy-seven thousand two-hundred ninety-five and 55/100 dollars (\$77,295.55). The Corporate Authorities of the Village further authorize and direct the Village President to take any and all actions, including the execution of any and all documents, necessary to enter into an agreement with Hamann Wagner Excavating, Inc. for the purpose of completing the project.

SECTION 3. In the event that any provision or provisions, portion or portions, or clause or clauses of this Resolution shall be declared to be invalid or unenforceable by a Court of competent jurisdiction, such adjudication shall in no way affect or impair the validity or enforceability of any of the remaining provisions, portions, or clauses of this Resolution that may be given effect without such invalid or unenforceable provision or provisions, portion or portions, or clause or clauses.

**SECTION 4.** All ordinances, resolutions, motions, or parts thereof, conflicting with any of the provisions of this Resolution, are hereby repealed to the extent of the conflict.

SECTION 5. The Village Clerk is hereby directed to publish this Resolution in pamphlet form.

<u>SECTION 6.</u> This Resolution shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.
