# A RESOLUTION AUTHORIZING THE VILLAGE PRESIDENT TO SIGN A RESOLUTION OF AUTHORIZATION FOR AN OPEN SPACE LAND ACQUISITION AND DEVELOPMENT 'OSLAD" GRANT APPLICATION FOR THE BRADLEY SPORTS COMPLEX

WHEREAS, the Village of Bradley is not a home rule municipality within Article VII, Section 6A of the Illinois Constitution and, pursuant to the powers granted to it under 65 ILCS 5/1-1 et seq.; and,

WHEREAS, an OSLAD Grant can be requested for acquisition and/or development of land for public outdoor recreation purposes; and

WHEREAS, the OSLAD Grant Program operates on a reimbursement basis providing up to a fifty percent (50%) assistance for approved project costs, with a maximum award of six hundred thousand dollars (\$600,000.00); and

WHEREAS, an applicant as part of its proposal, must adopt and submit a Resolution of Authorization by August 31, 2023 certifying and acknowledging that it has 100% of the funds necessary to complete the project within the timeframe specified; and

WHEREAS, the Village's Administration office with the assistance from their engineering firm is preparing a grant proposal for the Bradley Sports Complex "the Project"; and

WHEREAS, the Village Board will designate matching funds up to forty three million three hundred twenty eight thousand four hundred and two dollars (\$43,328,402.00) in unspent bond proceeds within the Capital Projects Fund; and

WHEREAS, the Village Board has determined that it is in the best interests of the Village of Bradley to submit an application for the Project to the OSLAD Grant Program of the Illinois Department of Natural Resources.

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:

**SECTION 1.** Toe foregoing recitals are hereby found as fact and incorporated herein by reference.

SECTION 2. The Village Board adopts the State of Illinois OSLAD Doc-3 Resolution of Authorization "Resolution of Authorization" attached hereto and incorporated by reference as Exhibit "I".

<u>SECTION 3.</u> Toe Village President is hereby authorized and directed to execute the Resolution of Authorization and the OSLAD Program Grant Application by and between the Village of Bradley and the Illinois Department of Natural Resources.

SECTION 4. The Village President is hereby authorized and directed to negotiate any additional conditions of the Resolution of Authorization and the OSLAD Program Grant Application as he may determine to be in the best interest of the Village.

**SECTION 5.** That this Resolution shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
