# A RESOLUTION APPROVING THE ACCEPTANCE OF A PARCEL OF LAND HAVING PARCEL NO. 17-09-09-303-020 BY THE VILLAGE OF BRADLEY

- <u>Froperty Accepted Subject to Liens of Record and Unpaid Property</u>


  Taxes The portion of the Parcel to be deeded to the Village, identified by its legal description on Exh. A, would remain subject to property taxes (first and second installments) for that portion of 2016 from 1/1/2016 thru the date of acceptance of the parcel by the Village and the recognition of exempt status by the State. The 2015 property tax bill (payable in 2016) is attached hereto as Exh. B. The 2016 property taxes are not yet known.
- <u>Section 3.</u> <u>Property History.</u> The portion of the parcel to be deeded to the Village is currently unused and vacant.
- <u>Section 4.</u> <u>Authorization</u>. The Village President and Village Clerk are authorized to execute and record such documents as may be necessary to effectuate the transfer of the Parcel from the Owner to the Village of Bradley.
- Section 5. Severability and Repeal of Inconsistent Ordinances and Resolutions. If any section, paragraph, clause or provision of this Resolution shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Resolution. All existing resolutions and ordinances of the Village of Bradley are hereby repealed insofar as they may be inconsistent with the provisions of this Resolution.
- Section 6. Effective Date. This Resolution shall be in full force and effect from and after its passage and approval as provided by law.
