**A RESOLUTION AUTHORIZING AND APPROVING THE SOLE SOURCE PURCHASE  
OF A POWER LOAD AND STRETCHER FOR THE VILLAGE OF BRADLEY,  
KANKAKEE COUNTY, ILLINOIS**

**WHEREAS**, the Corporate Authorities of the Village of Bradley, Kankakee County, Illinois, have the authority to adopt resolutions and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens; and

**WHEREAS**, pursuant to Section 2-3-8 of the Illinois Municipal Code (65 ILCS 5/2-3-8), the Corporate Authorities of the Village have the authority to enter into contracts, to make purchases, and to acquire and hold personal property for all legitimate corporate purposes; and

**WHEREAS**, the Corporate Authorities of the Village have determined that it is necessary, expedient, and in the best interests of the Village and its citizens to purchase a power load and stretcher for use by the Bradley Fire Department (the "Equipment"); and

**WHEREAS**, Village Staff have, through the sole source provider Stryker Sales Corp Portage, MI , will be selling the equipment to the Village in a manner and timeframe that fits the Village's present needs; and

**WHEREAS**, the total expected cost of the equipment is forty four thousand eight hundred and forty one dollars and 76/100 (\$44,841.76)

**WHEREAS**, the Corporate Authorities of the Village have determined that it is in the best interests of the Village and its citizens to authorize and approve the purchase of the Equipment from the Vendor at the price stated above, and further to waive competitive bidding in relation to said purchase.

**NOW THEREFORE, BE IT RESOLVED BY THE CORPORATE AUTHORITIES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:**

**SECTION 1.** The Corporate Authorities hereby find that all of the recitals contained in the preamble to this Resolution are true, correct, and complete and are hereby incorporated by reference hereto and made a part hereof.

**SECTION 2.** The Corporate Authorities of the Village hereby authorize and direct the Fire Chief for the Village of Bradley, Don Kaderabek, to purchase power load & stretcher (the "Equipment") from the Vendor, provided that the total price for the Equipment shall not exceed is forty four thousand eight hundred and forty one dollars and 76/100 (\$44,841.76). The Fire Chief is further authorized and directed to take any action and sign any document necessary to accomplish the purchase of the Equipment, as authorized by this Resolution

**SECTION 3.** In the event that any provision or provisions, portion or portions, or clause or clauses of this Resolution shall be declared to be invalid or unenforceable by a Court of competent jurisdiction, such adjudication shall in no way affect or impair the validity or enforceability of any of the remaining provisions, portions, or clauses of this Resolution that may be given effect without such invalid or unenforceable provision or provisions, portion or portions, or clause or clauses.

**SECTION 4.** All ordinances, resolutions, motions, or parts thereof, conflicting with any of the provisions of this Resolution, are hereby repealed to the extent of the conflict.

**SECTION 5.** The Village Clerk is hereby directed to publish this Resolution in pamphlet form.

**SECTION 6.** This Resolution shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.


