# A RESOLUTION AUTHORIZING A CHANGE ORDER FOR THE CONSTRUCTION CONTRACT BETWEEN THE VILLAGE OF BRADLEY AND MIDAS MIDWEST, LLC

- WHEREAS, the Corporate Authorities of the Village of Bradley, Kankakee County, Illinois, have the authority to adopt resolutions and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens; and
- WHEREAS, on September 23, 2019, the Corporate Authorities approved a construction contract (the "Contract") between the Village of Bradley and Midas Midwest, LLC (the "Contractor"); and
- WHEREAS, the Contract concerns the Village's ongoing 2019 Sanitary Manhole Rehabilitation Project (Basin #3 and Basin #5) (the "Project"); and
- WHEREAS, pursuant to the terms of the Contract, the Contractor was supposed to reach substantial completion under the contract on or before November 29, 2019, and final completion on or December 28, 2019, with all paving work being completed no later than November 16, 2019; and
- **WHEREAS**, on November 11, 2019, the Contractor requested an one-hundred and eighty (180) day extension of the time in which to complete the work of the Contract (*i.e.* until April 11, 2020) on account of unfavorable weather conditions; and
- **WHEREAS**, on November 13, 2019, the Village granted the Contractor's request and extended the deadline for final completion of the work until April 11, 2020; and
- WHEREAS, as of the date of this Resolution, the Contractor has not reached final completion because of (i) unfavorable weather conditions and (ii) travel and business restrictions imposed by local, state, and federal governments during the COVID-19 pandemic; and
- WHEREAS, the Contractor has requested an extension of the final completion date until June 30, 2020, to allow it to complete the work of the Contract; and
- WHEREAS, the Contractor and the Village have negotiated a proposed change order, a copy of which is attached hereto as Exhibit A and fully incorporated herein (the "Change Order"), that extends the Contractor's deadline for final completion of the Contract work to June 30, 2020; and
- WHEREAS, the Corporate Authorities of the Village have determined that it is in the best interests of the Village and its citizens to execute the Change Order between the Village and the Contractor.

NOW THEREFORE, BE IT RESOLVED BY THE CORPORATE AUTHORITIES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:

**SECTION 1.** The Corporate Authorities hereby find that all of the recitals contained in the preamble to this Resolution are true, correct, and complete and are hereby incorporated by reference hereto and made a part hereof.

SECTION 2. The Corporate Authorities of the Village hereby determine and declare that the terms and provisions of the Change Order, a copy of which is attached hereto as Exhibit A and fully incorporated herein, are reasonable, acceptable to the Village, and hereby approved in form and substance. The Acting Village President, Michael Watson, is hereby authorized and directed to sign, and the Village Clerk is directed to attest, said Change Order and to further take any other action, including signing any document, that is necessary, in his opinion, to fully execute and effectuate the Change Order as between the Village and the Contractor.

SECTION 3. In the event that any provision or provisions, portion or portions, or clause or clauses of this Resolution shall be declared to be invalid or unenforceable by a Court of competent jurisdiction, such adjudication shall in no way affect or impair the validity or enforceability of any of the remaining provisions, portions, or clauses of this Resolution that may be given effect without such invalid or unenforceable provision or provisions, portion or portions, or clause or clauses.

**SECTION 4.** All ordinances, resolutions, motions, or parts thereof, conflicting with any of the provisions of this Resolution, are hereby repealed to the extent of the conflict.

**SECTION 5.** The Village Clerk is hereby directed to publish this Resolution in pamphlet form.

**SECTION 6.** This Resolution shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.


