NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BRADLEY, WILL COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY AS FOLLOWS:

SECTION 1. The Village President and Board of Trustees hereby find that all of the recitals contained in the preamble to this Resolution are true, correct and complete and are hereby incorporated by reference thereto and made a part hereof.

SECTION 2. The attached Settlement Agreement and General Release between the Village, Bradley Fire Fighters Association Local 4288 of the International Association of Fire Fighters, AFL-CIO, CLS, and Michael McCue, Brian McHugh and Kyle Haemker is hereby approved, and the Village President and Village Clerk are hereby authorized to execute the attached Agreement on behalf of the Village.

SECTION 3. This Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.

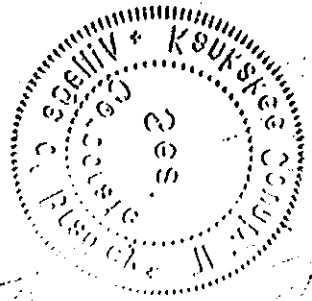
