## A RESOLUTION RESCINDING THE VOTE APPROVING RESOLUTION NO. R-4-19-3

WHEREAS, the Corporate Authorities of the Village of Bradley, Kankakee County, Illinois, have the authority to adopt resolutions and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens; and

WHEREAS, at a regular meeting of the Village Board held on April 22, 2019, the Corporate Authorities of the Village passed Resolution No. R-4-19-3 ("A Resolution Approving Third Extension to an Intergovernmental Agreement Between the County of Kankakee, City of Momence, Village of Bourbonnais, Village of Bradley, and the Village of Manteno for the Promotion of Tourism") (the "Resolution"); and

WHEREAS, the Corporate Authorities of the Village have determined that it is in the best interests of the Village to rescind the vote authorizing the Resolution.

NOW THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:

<u>SECTION 1.</u> The Corporate Authorities hereby find that all of the recitals contained in the preamble to this Resolution are true, correct, and complete and are hereby incorporated by reference hereto and made a part hereof.

SECTION 2. The vote of the Corporate Authorities of the Village on April 22, 2019, passing the Resolution is hereby rescinded and declared to be null and void.

SECTION 3. All ordinances, resolutions, motions, or parts thereof, conflicting with any of the provisions of this Resolution, are hereby repealed to the extent of the conflict.

**SECTION 4.** The Village Clerk is hereby directed to publish this Resolution in pamphlet form.

SECTION 5. This Resolution shall be in full force and effect immediately upon passage, approval, and publication in pamphlet form as provided by law.
