A RESOLUTION APPROPRIATING FUNDS FOR CERTAIN ROADWAY IMPROVEMENTS ON AND NEAR STATE ROUTE 50 WITHIN THE CORPORATE BOUNDARIES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS

WHEREAS, the Corporate Authorities of the Village of Bradley, Kankakee County, Illinois, have the authority to adopt resolutions and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens; and

WHEREAS, the Village of Bradley ("Village") has entered into an Intergovernmental Agreement (the "Agreement") with the State of Illinois, by and through the Illinois Department of Transportation ("IDOT"), for the purpose of improving Route 50 (Kinzie Avenue) within the corporate boundaries of the Village and other related work (collectively the "Road Project"); and

WHEREAS, the entire length of the Road Project is from 597 feet south of Armour Road to 768 feet north of Armour Road on IL 50 and from 1,188 feet west of IL 50 to 1,082 feet east of IL 50, and as such it falls within the corporate boundaries of the Village. The Road Project is identified as FAP 840 (IL 50), State Section 140 N Job No. C-93-051-20 and Contract No. 66957; and

WHEREAS, the Road Project and the Agreement contemplate the widening and resurfacing of the existing pavement of IL 50 and Armour Road, along with other related work, including but not limited to the installation and new traffic signals, new highway lighting, new sidewalks, a 10-foot shared use path, and new drainage systems along IL 50 and Armour Road; and

WHEREAS, as set forth in the Agreement, the Village has agreed to share the costs of the Road Project with IDOT; and

WHEREAS, pursuant to Section 5 ILCS 220/4 of the Intergovernmental Cooperation Act, the Village is authorized to appropriate funds for the Road Project; and

WHEREAS, pursuant to the Agreement, the Village wishes to appropriate a sum of one hundred fifty thousand and 00/100 dollars (\$150,000.00) to satisfy its reimbursement obligations under the Agreement.

WHEREAS, the Village President and Board of Trustees have determined that both (1) the Village's participation in the Agreement and (2) the appropriation under this Resolution are in the best interests of the citizens of the Village.

NOW THEREFORE, BE IT RESOLVED BY THE CORPORATE AUTHORITIES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:

SECTION 1. The Corporate Authorities hereby find that all of the recitals contained in the preamble to this Resolution are true, correct, and complete and are hereby incorporated by reference hereto and made a part hereof.

SECTION 2. That a sum totaling one hundred fifty thousand and 00/100 dollars (\$150,000.00) is hereby appropriated by the Village of Bradley and allocated to satisfy its obligations as set forth in the Agreement. The Village also anticipates that it may be necessary to appropriate additional funds in the future, as necessary to satisfy its obligations under the Agreement.

SECTION 3. That the funds appropriated by this Resolution shall be paid out as set forth in and pursuant to the terms of the Agreement, based upon final quantities and bid unit prices of the awarded contract.

SECTION 4. In the event that any provision or provisions, portion or portions, or clause or clauses of this Resolution shall be declared to be invalid or unenforceable by a Court of competent jurisdiction, such adjudication shall in no way affect or impair the validity or enforceability of any of the remaining provisions, portions, or clauses of this Resolution that may be given effect without such invalid or unenforceable provision or provisions, portion or portions, or clause or clauses.

SECTION 5. All ordinances, resolutions, motions, or parts thereof, conflicting with any of the provisions of this Resolution, are hereby repealed to the extent of the conflict.

SECTION 6. The Village Clerk is hereby directed to publish this Resolution in pamphlet form.

SECTION 7. This Resolution shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.
