A RESOLUTION ACKNOWLEDGING THE EXISTENCE OF A VACANCY IN THE OFFICE VILLAGE TRUSTEE FOR THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS

WHEREAS, the Corporate Authorities of the Village of Bradley, Kankakee County, Illinois, have the authority to adopt resolutions and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens; and

WHEREAS, on May 20, 2021, Trustee Michael Watson tendered his written, signed, and notarized unconditional letter of resignation from the office of village trustee, effective Sunday, May 23, 2021, to the village official authorized to fill vacancies in the office of village trustee; and

WHEREAS, by virtue of said resignation from the office of trustee and by operation of law pursuant to Section 3.1-10-50(d) of the Illinois Municipal Code (65 ILCS 5/3.1-10-50(d)), Mr. Watson is now vested with all powers and duties of the office of Village President and is further authorized to vote and veto in the manner provided by law for a village president; and

WHEREAS, by virtue of said resignation and by operation of law pursuant to Section 3.1-10-50(a)(3) of the Illinois Municipal Code (65 ILCS 5/3.1-10-50(a)(3)), a vacancy in the office of village trustee was created on May 23, 2021.

WHEREAS, the Corporate Authorities of the Village have determined that it is necessary and expedient to pass this resolution acknowledging the existence of a vacancy in the office of village trustee.

NOW THEREFORE, BE IT RESOLVED BY THE CORPORATE AUTHORITIES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:

<u>SECTION 1.</u> The Corporate Authorities hereby find that all of the recitals contained in the preamble to this Resolution are true, correct, and complete and are hereby incorporated by reference hereto and made a part hereof.

SECTION 2. The Corporate Authorities hereby acknowledge and affirm the existence of a vacancy in the office of village trustee on account of Trustee Michael Watson's resignation from that office on Sunday, May 23, 2021.

SECTION 3. In the event that any provision or provisions, portion or portions, or clause or clauses of this Resolution shall be declared to be invalid or unenforceable by a Court of competent jurisdiction, such adjudication shall in no way affect or impair the validity or enforceability of any of the remaining provisions, portions, or clauses of this Resolution that may be given effect without such invalid or unenforceable provision or provisions, portion or portions, or clauses.

SECTION 4. All ordinances, resolutions, motions, or parts thereof, conflicting with any of the provisions of this Resolution, are hereby repealed to the extent of the conflict.

SECTION 5. The Village Clerk is hereby directed to publish this Resolution in pamphlet form.

SECTION 6. This Resolution shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.
