**ORDINANCE NO. R-08-22-4**

**A RESOLUTION AUTHORIZING WITHDRAWAL FROM THE ILLINOIS MUNICIPAL INSURANCE COOPERATIVE**

**WHEREAS**, the Village of Bradley is not a home rule municipality within Article VII, Section 6A of the Illinois Constitution and, pursuant to the powers granted to it under 65 ILCS 5/1-1 et seq.; and,

**WHEREAS**, the Village of Bradley (“Village”) has been a member of the Illinois Municipal Insurance Cooperative (“IMIC”) since 2013; and

**WHEREAS**, the Village is a party to a certain Intergovernmental Agreement between IMIC and the Village (“the IGA); and

**WHEREAS**, the IGA permits withdrawal from IMIC by the adoption of a Resolution approving a Notice to Withdrawal to the IMIC Administrator and Chairperson; and

**WHEREAS**, the Notice of Withdrawal must be delivered prior to September 1.

**NOW THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:**

**SECTION 1.** That the Notice of Withdrawal attached hereto as Exhibit A is hereby approved and the Village Finance Director is authorized and directed to deliver the Notice of Withdrawal together with a true and correct copy of this Resolution to the Chairman and Administrator of IMIC prior to September 1.

**SECTION 2.** If any section, paragraph, clause or provision of this Resolution is held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any other provisions of this Resolution.

**SECTION 3.** All notices, resolutions, orders or parts thereof, which conflict with the provisions of this Resolution, is to the extent of such conflict, hereby repealed.

**SECTION 4.** That this Resolution shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.

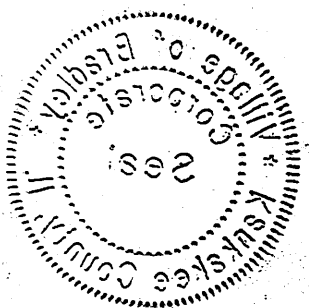
